RUSSIA OFFERS TO NEGOTIATE BAN

On Condition U. S. Cancels Pacific Tests

GENEVA (UPI) - Russia offered today to negotiate a nuclear test ban on the basis of a neutral proposal providing the United States cancels plans for nuclear explosions in the Pacific. But the United States said it would not be caught again in the trap of an unpoliced moratorium which Russia could break at will, and will call off the tests only when a treaty effectively banning them is signed.

Extra Meetings

The 24th plenary session held this morning was to have been the last before beginning the Easter recess, but Zorin forced a session of an Anglo-American-Soviet subcommittee this afternoon. He warned that another plenary meeting tonight or Friday morning would be necessary.

East and West exchanged bitter remarks in dealing with a neutral proposal it had been hoped would bring the great nuclear powers closer together.

Allied Viewpoint

U. S. Ambassador Arthur H. Dean and British Minister of State Joseph Godber said the neutral proposal was unclear, but they interpreted it to mean the neutrals accept the principle that a test ban must be built on the foundation of a global international control system and on-site inspections by an international commission.

Winner Of Long, Hot Battle

First Citizens Granted Branch At Buie's Creek

One of the State's hottest banking fights for the last four years came to an apparent close Wednesday as the State Banking Commission approved an application from First-Citizens Bank & Trust Co. of Smithfield to open a branch in Buie's Creek.

It marked the third time that First-Citizens had applied for a branch in the Harnett County town.

In January, 1961, the Bank of Lillington in Harnett won approval for a Buie's Creek branch as First-Citizens was turned down for the second time.

But State Treasurer Edwin Gill, who heads the Banking Commission, said the Bank of Lillington had never established the approved branch in Buie's Creek.

The commission has a regulation that approved applications are void if the bank concerned fails to carry out its intentions within one year after the date of approval, Gill said.

Other State banking officials said the regulation provides that banks can seek a time extension after the one-year limit expires by writing Commissioner of Banks Ben Roberts. The Bank of Lillington had not sought such an extension.

Buie's Creek, home of Campbell College and its 1,400 students, has been without a bank for many years. First-Citizens and the Bank of Lillington were both turned down when they applied for a branch there in 1958.

"The community has demonstrated on many occasions its sincere desire for banking facilities," Lewis R. Holding, president of First-Citizens, told the Banking Commission.

Dr. Leslie Campbell, president of Campbell College, and a number of other citizens of the community were present in behalf of the application.

Holding said after the meeting that he hopes to have the new branch completed and open for business within three or four months.

Obstructions Must Be Removed

Builders Are Warned About Regulations

Contractors and others who are planning construction projects were reminded today by City Manager Archie Uzzle that steps and other obstructions are not allowed to be built in the street right-of-way in any case.

This includes the sidewalk area which is part of the street right-of-way. Steps and other obstructions are to be built only on private property.

All sidewalk construction on street right-of-way requires a written permit from the Town of Dunn, as also does any digging on street rights-of-way. To build or place steps or obstructions on street rights-of-way not only produces dangerous situations but also
