

Defendant Is Fined \$15

Witnesses Almost Landed Up In Jail

The case of Edward Eugene Poole, 29, of Selma, charged in Dunn city court with speeding and driving with an expired license, turned out to be more than a routine traffic trial.

Three lady companions who testified in an attempt to exonerate Poole of the charges almost went to jail for contempt of court.

Poole was indicted after an accident by State Trooper W. T. Harris on Saturday night, July 19. At the time, Poole said, he was enroute to Sherrill Coats' grill, accompanied by two teenage girls, an older woman and a man.

The accident occurred on the old fairground road. Two Benson teenagers, Steve Dixon and Timothy Johnson, eye witnesses, testified for the State. They said Poole lost control of the car on a curve and overturned in a ditch.

The girls who testified for him were: Miss Phyllis Parrish, 16, of Micro, who said she had lived in a Brenda Avery, for the past three months. She said Poole was forced off the road by an approaching car.

Her 18-year-old sister, Mrs. Blanche Martinez, married to a serviceman now in Germany, and Mrs. Helen Stanley, 49, of Selma, also testified for him, as well as the other man, Harvey Starling. All said they had been to the grill for a dance earlier that night.

Asked by Solicitor Howard Godwin if the place didn't have a bad reputation, Mrs. Martinez said

"Yes, but you can have a lot of fun at dances there." She admitted seeing drinking there.

Judge Hill criticized the conduct of the two teenage girls, particularly the 18-year-old who lived "without means of visible support." The girls wise-cracked back at the judge with some snappy remarks.

"I'll hold all three of you for contempt of court if you don't leave this courtroom right now," warned His Honor.

Judge Hill fined Poole \$15 and took his license.

ECONOMIC INDICATORS

WASHINGTON (UPI) — Cash dividend payments and durable goods manufacturer's shipments and new orders — three key economic indicators — advanced in July but a fourth, housing starts, declined, according to figures compiled by the Commerce Department.

Private housing starts declined to a seasonally adjusted annual rate of 1.5 billion units — down five per cent from June and four per cent below July 1963. Home building is one of the new segments of the economy that has failed to advance since the \$11.5 billion tax cut.
