"I Will Repay"

"For we know Him that hath said, Vengeance belongeth unto Me, I WILL RECOMPENSE (repay), saith the Lord..." (Heb. 10:30)

Now what is VENGEANCE? Vengeance is God punishing you for your sins against Him. Vengeance is not REVENGE. Revenge is spiteful injury to another for a possible injury for what he may have done to you, or for some injury you think the other fellow has brought on you. God hands out vengeance justly according to your sins, and man hands out revenge based on the human heart which is hatred, meanness, ignorance, and pride!

The old men used to pray: "Lord, it's mercy we want, for justice is crying out us down." Let me explain that just a little. It means that if God were to give you and me justice He would send us to Hell. If God should mark iniquity, no man could stand (Ps. 130:3).

A man here at the office said he had read our message in the POST. Well, I'm glad for him, maybe the Lord will get hold of your heart. I'm praying the Lord will get hold of your heart, awaken you to the fact you are a lost sinner, bring you down in repentance and give you faith to lay hold on Christ as your Lord and your Saviour. When someone found out that the judge was on my mailing list they were surprised. I replied like this: the judge has just as much right to be saved as anyone else. That's right, why should you not want the judge to receive the Gospel and be saved? I praise the Lord that salvation is not in the hands of any man. I told the judge it was a joy to talk with him that day but the greatest joy was when I came to know Jesus Christ as my Lord and my Saviour. My friend, if you ever come to know Christ it will be the greatest thing that ever happened to you. And as Bro. Shelton used to say: "You'll never have an experience after you are saved that will eclipse your salvation in Christ." That's right.

If you cannot go back to the time you were a lost sinner and tell what God saved you from, and what God saved you to then you are not saved. When were you lost? When did the Holy Spirit throw back the cover of your heart and let you see you were a totally depraved, wrecked and ruined sinner in your filthy rags on the road to Hell? How about it my friends? Do you know Christ? Is He real to you? He is to me.

I praise the Lord for His superintendence and every care over me. You may lift your hand against me but my Lord will meet out vengeance to you. You may wage a slander campaign against me to wreck me, that Lord will see to wreck me, the Lord will see

to you. Let me make this statement: every soul who has ever risen up against the truth and against God's anointed has always gone down. The Lord said in I Chron. 16:22 and in Ps. 105:15 saying: "Touch not Mine anointed, and do my prophets no harm."

Here is the promise of my Lord to me: "No weapon that is formed against thee shall prosper; And every tongue that shall rise against thee in judgement thou shalt condemn: This is the heritage of the servants of the Lord, and their righteousness is of Me, said the Lord" (Isa. 54:17). Praise the Lord. I don't have to fear what any man shall plot against me. Nothing you do to cast me down shall stand. The Lord holds the king's heart in His hands. Listen, did you get those words "thou shalt condemn?" To condemn means to judge. You say you thought you weren't supposed to judge. Who told you that? The Lord said thou (meaning His servants) shalt judge. Where? At the Great White Throne Judgment, according to Rev. 20:11,12. As the servant of the Lord I'll have to take the stand there and witness against every soul I knew here in life who refused to repent and believe the Gospel. I am going to have to witness against the high and low. Men who held high office right here, I'll have to step forward when the question is asked: "Does anyone know this man here?" "Yes, Lord I knew him, we worked together, he spurned the Gospel, trampled the blood under his unhallowed feet" (Heb. 10).

You may have held a high office, you may boast that you have the authority to say to men: go here, or go there, do this and do that, but all that will mean nothing to you than when you are brought in to be tried for all your sins at the Great White Throne Judgment. NOTICE OF PUBLIC HEARING

Re: Federal Operating Assistance for Charlotte's Intra-City Bus System

1. Notice is hereby given that a public hearing will be held by the City of Charlotte in the second floor Council Chamber of Charlotte City Hall, 600 East Trade Street, Charlotte, at 7:00 P.M. on December 22, 1976, for the purpose of considering a project for which financial assistance is being sought from the Urban Mass Transportation Administration, pursuant to the Urban Mass Transportation Act of 1964, as amended, generally described as follows:

A. DESCRIPTION OF PROJECT:

(1) Seek operating assistance funds under section 5 of the Urban Mass Transportation Act of 1964, as amended November 25, 1974. Operating assistance is sought for the purpose of aiding the City of Charlotte in the preservation and continuation of the existing public transportation system by improvement, and expansion of the system through the expenditure of "local share" money and Federal grant funds.

(2) The public transportation system is managed by the Charlotte City Coach Lines, Incorporated with offices, maintenance, servicing and storage facilities located at 707 North Brevard Street, Charlotte, North Carolina.

B. RELOCATION:

No persons, families, or business will be displaced by this project.

C. ENVIRONMENT:

The proposed project will have no significant environmental impact upon the Charlotte urbanized area in FY 1977.

D. COMPREHENSIVE PLANNING:

This project is in conformance with comprehensive land use and transportation planning in this area. Comments favorable to and in concurrence with this project have been made by the Charlotte-Mecklenburg County Planning Commission, the Metropolitan Planning Organization for the Charlotte Urbanized Area.

E. ELDERLY AND HANDICAPPED:

The proposed project has provision for charging no more than one-half of the peak hour fare to elderly and handicapped persons.

11. At the hearing the City of Charlotte will afford an opportunity for interested persons or agencies to be heard with respect to the social, economic, and environmental aspects of the project. Interested persons may submit orally or in writing evidence and recommendations with respect to said project.

A copy of the application for a Federal grant for the proposed project together with an environmental statement and the transit development plan for the area, is currently available for public inspection at Charlotte City Hall, 600 East Trade Street, Charlotte, North Carolina, in the office of the City Clerk.
