Kennedy Joins

CHICAGO - Casper W. Weinberger, President Ronald Reagan's nominee for Secretary of Defense, resigned effective today from the Board of Directors of The Quaker Oats Company.

Elected to succeed Mr. Weinberger is William J. Kennedy III, President, CEO, and Chairman of the North Carolina Mutual Life Insurance Company

Mr. Kennedy, 58, heads one of the leading predominantly black-managed financial institutions in the United States. A graduate of Virginia State College, he received two MBA degrees - one from the Wharton School of Finance and Commerce of The University of Pennsylvania and the other from New York University.

Mr. Kennedy joined North Carolina Mutual in 1950, became Controller in 1959, Senior Vice President in 1970, and was appointed President in 1972.

Mr. Kennedy is a director of several corporations, including Mobil Corp., Pfizer, Inc., and the Urban National Corporation. He has also been active in numerous professional and organizations

Mr. Weinberger, 63, was formerly Vice President and General Counsel of the Bechtel Corp., San Francisco.

During the same year, the section, with the cooperation of county social services departments, health care providers, attorneys, and insurance the Third Party Recovery companies, recovered \$8.7 million in Medicaid payments from insurance companies and other sources.

"This was a significant increase over the \$5.6 million collected the previous year which was the first full fiscal year the section was in operation. The budgeted cost to operate the section was only \$150,000 during 1979-80. This means for every dollar it cost the state to operate this section, it returned \$57 to the state," said Donald Best, head of the Third Party Recovery Section.

Medicaid, a program to provide health care for eligible poor people, is a federal program administered by states. In North Carolina, the majority of the funds that finance Medicaid are federal with the state and counties paying the remainder of the cost. County social services departments determine eligibility for the program based on federal and state requiremen's.

'Due to the continued escalation of Medicaid costs across the nation, the federal government issued a regulation that Medicaid would no longer pay for medical care that was the responsibility of other individuals, institutions, corporations, or public or private agencies. Medicaid became the 'Payor of last resort' after this regula-tion was adopted," Best

To accomplish this in North Carolina, the General Assembly passed a law in 1977 that became General Statute 108-61.4, accordingto Best. "This statute, as amended, gives the state an assignment of benefits for all Medicaid recipients, and it gives the state the right of subrogation. This means that the

responsible parties that money which is paid health care providers for care of Medicaid recipients that should have been paid by someone else.'

He indicated that the majority of the Medicaid funds recovered were from insurance companies. Some eligible Medicaid recipients also have small health insurance policies that provide limited benefits. In other cases where medicaid recipients are involved in accidents, such as an automobile mishap, if the other party involved is liable, we seek settlements from their insurance com-

He cited an example of a 35 year old single man who was involved in an automobile accident and received injuries that left him totally disabled. "The accident happened in 1977 and the man is still confined to a nursing home with Medicaid paying the bills. The other party involved was determined at fault. After the insurance settlement, we recovered \$35,000 from his insurance company.'
