Notice Of Proposed Class Action Settlement Against North Carolina Air National Guard

This notice is being given as part of a proposed settlement of a class action lawsuit alleging racial discrimination against the North Carolina Air National Guard. Neither the plaintiffs nor the defendants have finally agreed to any settlement of this case. Further, any ultimate settlement would have to be approved by the Court, and this has not yet occurred. This action was initiated on May 10, 1977 by plaintiffs Ernest H. Mackey and Jimmy Hoard. Plaintiffs alleged that the North Carolina Air National Guard had discriminated against them and other black persons in denying them employment opportunities as technicians because of their race. The Court certified this proceeding as a class action on July 13, 1978 and defined the class as consisting of the following persons:

1. All black employees who are or have been or may be employed by the North Carolina Air National Guard at its Charlotte, North Carolina, facility since March

2. All black persons who have sought or applied for employment with the North Carolina Air National Guard at its Charlotte, North Carolina, facility since March 24, 1972:

3. All other black persons who have been or will be otherwise adversely affected by any alleged discriminatory employment practices or acts of the North Carolina Air National Guard at its Charlotte, North Carolina, facility since March 24, 1972.

This Notice is being published in order to advise potential class members of their rights under the proposed settlement and to notify them of the further steps that THEY MUST TAKE if they desire to assert any claim individually on their own behalf.

The Court has not made any judgment as to whether any particular individual has or has not been discriminated against. That decision will be made only after all parties have had the opportunity to present in Court whatever evidence each party desires to present.

Plaintiffs have asserted that the North Carolina Air National Guard has discriminated against black

persons in the following ways:

1. By the use of vague standards in making promotion and employment decisions which allow an all white supervisory staff to make discriminatory

2. By not adequately publicizing the availability of job positions as technicians: 3. By limiting the opportunity to seek technician

positions to persons who are already technicians; 4. By applying different standards to black and white

applicants for job vacancies.

In listing these contentions, the Court has not made any judgment as to whether any one or more of these

claims has any legal merit. These claims are listed merely to inform class members of the general types of claims which plaintiff are making. If you are a class member, you can raise any claim in this proceeding which is related to discrimination on account of race in promotion, hire or assignment in the technician gram. This case does not directly relate to military gnment or promotion. You should understand the North Carolina Air National Guard has denied that it has discriminated against any individual in any of the ways listed above or in any other way.

If you feel that you have been discriminated against in not being hired or promoted or assigned as a technician or in not being allowed to compete for a technician position with the North Carolina Air National Guard, you MUST NOW file a claim in this proceeding to have your claim heard and a decision rendered by the United States District Court for the Western District of North Carolina. In order to file a claim, you must contact the Clerk of the United States District Court, Western District of North Carolina, P. O. Box 31757, Charlotte, N.C. 28231, telephone 704-371-6202 and ask to receive a claim form. No claims will be considered unless you have filed a claim form with the Clerk. Simply calling the Clerk is not sufficient. You must file your claim on or before March 30, 1981, or if you receive a notice by mail, within 30 days of received of that notice, whichever of the two above dates is later. You may file a claim for any alleged act of discrimination practiced against you between the date of March 24, 1972, and September 1, 1980. IF YOU DO NOT FILE A CLAIM BY THE DATE LISTED HEREIN, YOU WILL LOSE ANY RIGHT YOU MAY HAVE TO OBTAIN INDIVIDUAL RELIEF IN THIS

The plaintiffs are represented by local counsel, Louis L. Lesesne, Jr., of the law firm of Gillespie & Lesesne, 2060 First Union Plaza, Charlotte, North Carolina 28282, telephone 704-372-5700, as well as by out-of-state counsel. You have the right to direct any questions to these attorneys if you desire to file a claim by any other attorney of your own choosing. However, in order to have your claim heard in this case, you

must file a claim by the date set forth above. This the 19 day of January, 1981.


