"And to wait for His Son from heaven, whom He raised from the dead, even Jesus, which delivered us from the wrath to come." (1 Thess. 1:10). Every born-again believer is waiting for the Lord Jesus Christ to come from the third Heaven and take us home with Him. I'm waiting for Him. Are you? It is not a passive waiting, but an active waiting. That is: I anxiously look and long for His return.  
This message grew out of a statement a young woman made to me as I was preparing to leave Lenoir this past Friday where I had been stationed for almost four months. I stopped by the restaurant where I had been getting most of my meals and I told her that it may be the last time she would ever see me since I was leaving. She replied; "We may never meet here again, but we'll meet in Heaven." Yes, to all of you who know Christ, I'll meet you in Heaven when Christ comes. If you know Christ you'll be taken when He comes. Do you know Him? If you do then you, too, are waiting for Him, longing for Him, and you know that any moment the Lord could come. Yes, He is near, even at the doors; (Mt. 24).  
Also, I went by Mt. Pilgrim Baptist Church and in my closing remarks to the folks there I told them; "This may be the last time you'll see my face on this earth, you may never see me again until that time in the Word of God where a thousand years is one day, and a day a thousand years, the time of the Great White Throne Judgment."
