Mechanics And Farmers Shows Steady Growth

Mecklenburg County offices and agencies will be closed Monday, May 30, in observance


of Memorial Day. This includes all branches of the Public Library, Health Department, Department of Social Services, Tax Offices, Register of Deeds Office, and Elections Office.


