Negro Baseball Legends In Atlanta

ATLANTA - On June 4-5, Southern Bell and the Atlanta Braves will host a festivity-filled salute to the renowned baseball greats of the legendary Negro Baseball League of the 1920s.

The tribute will kick off Sunday, June 4, with a luncheon featuring keynote speaker William D. "Bill" White, president of the National League and the first black to hold such a position in the major league baseball organization.

Festivities will close with award presentations at the Atlanta-Fulton County Stadium on June 5 during a baseball doubleheader between the Braves and the Los Angeles Dodgers.

The two-day event is a reunion of surviving members of the former Negro Baseball League, who now number little more than 100. In addition to the kickoff luncheon and award ceremonies, the event also will feature a formal reception for players and other participants, and baseball clinics for high school and college players, conducted by the legends themselves.

Some former players already scheduled to participate in the tribute include Don Newcombe, who played with the Brooklyn Dodgers and Newark (New Jersey) Eagles; Ernie Banks, a Hall of Fame member formerly with the Chicago Cubs and Kansas City Monarchs; Joe Black, formerly with the Baltimore Elite Giants and the first, black major league pitcher to win a World Series game; Larry Doby, the first black player in the American League; and John "Buck" O'Neill, who also played with the Kansas City Monarchs and was the first black coach in the major leagues.

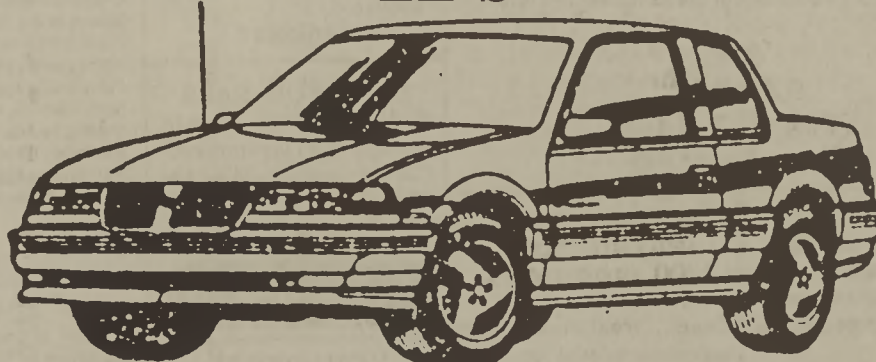

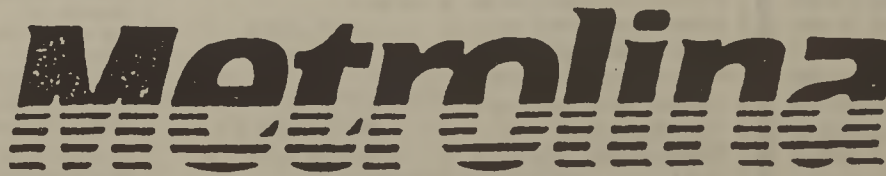
