Notification of Intent to Issue a NPDES Wastewater Permit

On the basis of thorough staff review and application of NC General statute 143.21, Public law 92-500 and other lawful standards and regulations, the North Carolina Environmental Management Commission proposes to issue a National Pollutant Discharge Elimination System (NPDES) wastewater permit to the person(s) listed below effective 45 days from the publish date of this notice.

Written comments regarding the proposed permit will be accepted until 30 days after the publish date of this notice. All comments received prior to that date are considered in the final determinations regarding the proposed permit.
