AND ENTHUSIASTIC LARGE CONVENTION.

Of the 8 Votes Anson Has in the State Convention Horne will Get 2.80 and Kitchin and Craig Each 2.60--Bryan Endorsed for President and John T. Bennett for Elector--Auson will Have 33 Delegates in the Convention to Cast Her 8 Votes.

The largest and most enthusiastic Democratic convention that has assembled in Anson since the change was made, in 1888, of nominating county candidate by a direct primary, assembled in the court house here Monday afternoon at 1:30 o'clock. The court room was filled to its capacity with representatives of the militant Democracy of the great Democratic county of Anson. The crowd was entirely good humored but it was evident that every man was on the lookout to see that no harm came to his cause or his candidate if he could prevent it.

The convention was called to order by County Chairman Jas. A. Lockhart, who requested Mr. John T. Bennett to act as temporary chairman and Mr. H. S. Boggan as temporary secretary. The roll was called and every precinct in the county was found to be represented with its full quoto of delegates. No contests were reported and the temporary organization was then, upon motion, made permanent.

On motion the chair appointed Messrs. F. J. Coxe, J. D. Horne and L. D. Robinson a committee of three to ascertain the number of votes by the three candidates for Governor, in the primaries and to report upon what proportion of the eight votes the county has in the state convention should be given each of the said candidates. The returns from the eleven precincts of the county placed in the committees hands showed that the following vote had been cast:

Tuesday afternoon Will Lee, colored, who lives in Ansonville township, got drenk and raised a disturbance in Rich Hammond's store, located on the Charlotte road. In response to a telephone message Policeman Redfearn went to the scene and arre ted Lee. Lee came along quiet. ly for some distance but finally broks away from the policeman and ran. Mr. Redfearn fired several times at the fleeing man, but, he says, did not try to hit him. After running some di tance the negro jumped a fence, and, as the officer approached, he told him not to come on him or he would shoot. At this time Lee was trying to open a small satchel he carried and Mr. Redfearn fired on him striking him in the thigh. The ne gro is also shot in the bottom of the Lowe; West sacrifices, scoring Leak; foot. This wound, it is claimed, was made by the same ball that entered the nogro's thigh, the theory being that he had his foot doubled up under him in such a way as to make it possible for the missle to enter the bottom of the foot after passing out

of the thigh. Lee's wounds are not considered serious unless complications arise, He was carried to his home yesterday afternoon by his father.
