The driver of a truck loaded with tobacco met instant death about seven o'clock Tuesday morning when the heavily loaded vehicle left Highway 70 at a curve near the old swimming pool on the eastern edge of Valdese and crashed into concrete guard posts

The Valdese Funeral Home, where the victim's body was taken, said identification papers and other items on his body showed his name to be Lloyd Howard Davis, age 30, of Greenville, Tenn. Shipping papers found in the truck indicated the cargo of tobacco was destined for Sanford, N. C.



Kaylor and Cook Found Not

Guilty In Two Other
