**PILING ON AVOIRDUPOIS.**

From 100 to 120 pounds of avoirdupois a week isn't bad gaining for sick folks, is it? That is just what from 80 to 90 tuberculosis patients are gaining at the State Sanatorium every week. What's more, they are doing that during hot weather.

Consumption is a wasting disease. As long as the disease is progressing, the victim loses flesh. When the patient begins to improve, one of the first symptoms is a gain in weight. A gain in weight means that not only is the course of the disease checked and this wasting process, or "consumption" halted, but that the tide of the battle is completely reversed, that tubercle bacilli are on the run and that the physical condition of the body is being rapidly improved.

Every Saturday morning each patient at the Sanatorium is weighed. They soon learn the meaning of a gain in weight, and a gain of a pound or two over the previous week is music in the patient's ears. Some of the patients at the Sanatorium, of course, gain faster than others. Some gain as much as four or five pounds a week. Others barely hold their own, and a few in the last stages may gain a little one week and lose a little next week, and so it goes. The total gain of all the patients amounts to from 100 to 120 pounds a week, or about three tons a year.

The great surprise to many people who visit the Sanatorium for the first time is the general health looking condition of the patients. Ordinarily, we expect tubercular people to be thin, poor and emaciated, but, as a layman expressed himself a few days ago, the patients he saw at the Sanatorium were a "healthier looking bunch than the general run of people over here on the streets of A——." Nor are they deceiving their looks. They are getting well and strong on Sanatorium treatment.

**A NEW RECRUIT FOR HOOKWORM FORCE.**

The Hookworm Bureau of the State Board of Health announces the addition of another member to its force in the person of Dr. W. H. Kibler, of Morgantown, N. C. Dr. Kibler is an A. B. graduate of the State University and a medical graduate of the University of Pennsylvania. He has had several years' experience in teaching scientific subjects in various schools and colleges in the State, and brings to the force a hearty sympathy for matters pertaining to rural sanitation and preventive medicine in general.

Dr. Kibler has selected the Mount Pleasant community, in Nash county, where he begins his work this week. It is significant that Nash is the only county in the State which has been able to secure two community health officers at the same time. The other, Dr. M. E. Champion, is located at Red Oak, a live community, a few miles north of Rocky Mount. The cause for this good showing in health matters is due to the tireless activity of Dr. B. E. Washburn, the whole-time health officer of the county.

Similar to the work that Dr. Kibler and Dr. Champion are engaged in are the "Wider Health Communities" now in operation at Salemburg, Edmonson county; Wrightsboro, New Hanover county; Hillsboro, Columbus county; Philadelphia, Robeson county. From all these communities come most satisfactory reports. In fact, the reports indicate that the work of the officers in some communities is nearing completion, which means new assignments are ready to be made.

The work is open to any rural community in the State. The only requirement is a specific promise of active and progressive cooperation on the part of the citizens with the health officer placed in charge. The State Board of Health is glad to receive applications from interested citizens.
