





### LIST YOUR REAL AND PERSONAL PROPERTY **DURING THE MONTH OF JANUARY**

All property owners and tax payers are required by law to return to the List Taxation for the year 1946, all the Real Estate, Personal Property, Etc., they own on the first day of January.
