It was September 27, 1939, and Elwood Mintz, a sophomore at Louisburg College, had been elected vice-president of the Y. M. C. A. there. Three slot machines had been confiscated by the Sheriff's Department; the Sea Owl, a yacht well known locally, had been in port on the preceeding weekend and had entertained Southport visitors; and daily shrimp catches were running from 12-45 bushels per boat. And in a front page item, with no names mentioned, it was reported that a breathless lady had arrived at one of the local churches on Sunday evening to sing the final hymn and hear the benediction pronounced. She had been unaware that the time for evening services had been upped an hour.

Our Not Exactly editor that week devoted considerable time and space to the canine citizens of Southport. He noted with some surprise the number of water spaniels in town, and made nominations for the most beautiful dog, an Irish setter belonging to H. B. Smith The Larsen service station at Sawdust Trail was now open for business; there were plans for construction of tennis courts at Leland High School; and there was some serious talk of constructing a fishing pier at Long Beach.

It was September 27, 1944, and news had come across coun-try that Lt. Cir. M. R. Sanders would shortly go to the South Pacific to set up a Naval repair base. One news article that week stated that school attendance laws would be obeyed, while another stated that Prof. Glen Tucker was quite well pleased with attendance at Bolivia.
