RULES AND REGULATIONS GOVERNING THE INSTALLATION OF PLUMBING OR WATER DRAINAGE PLANT IN BRUNSWICK COUNTY It shall be unlawful for any person, firm or corporation to install or build any residential or other type sewer disposal or plumbing plant at any residence, storehouse, factory or other place of residence or business in the County of Brunswick without first obtaining a permit from the Health Director of Brunswick County or his duly authorized agent. 2. Any residential sewage disposal plant installed in the County of Brunswick shall be constructed under the supervision of the County Health Director or his duly authorized agent. 3. All new plumbing shall be inspected in accordance with Article 29 of the North Carolina Building Code as amended by the North Carolina Building Code Council, or any subsequent amendments thereof. 4. Any installation of plumbing of any nature in the County of Brunswick shall be done under the supervision of the County Health Director or his duly authorized agent. 5. Every person desiring to engage in plumbing or water drainage in the County of Brunswick, shall have valid plumbing license issued by the County Health Director and is enforcing a Plumbing Code that meets the minimum requirements of the State Board of Health. 6.
