Schools sue to recover

Lid off equipment sale

The Brunswick County Board of Education filed a lawsuit Monday against Jones' Seafood Restaurant owner Jarvis Jones in an attempt to recover at least \$10,000 or the 46 pieces of cafeteria equipment Jones purchased in July for \$350 without the school board's authorization.

Jones then sold 12 pieces of equipment for \$7,800 to Ed's Carolina Restaurant Equipment store in Wilmington, owned by his nephew Ed Jones, according to Southport police chief Bob Gray's investigative report. Gray said Jones reportedly told his nephew he had paid \$4,300 for the equipment.

State statutes require the school board to adopt a resolution declaring equipment surplus before it can be

sold or auctioned. A violation of the statute is considered a felony, Gray

The 46 items -- including stacked ovens, ice machines, coolers, heaters, mop carts, milk coolers, steamers, fryers and trash compactors -- were purchased during the 1970s and 1980s

for a total of about \$70,000 and placed in the Southport Elementary School cafeteria. The equipment was removed last summer and stored in the warehouse when a new cafeteria was constructed.

'Regional planner is considered

The Southport Board of Aldermen gave mixed reviews Thursday night to the concept of hiring a joint planner for the Southport-Oak Island area.

The idea emerged at the November 13 meeting of southeastern Brunswick County elected officials, and local municipal leaders are being asked to comment on the proposal prior to the next elected officials' meeting in January.

While some aldermen said a joint planner would help ensure organized growth in the area, alderman Nelson Adams said he was reluctant to allocate Southport money to help

CP&L joins opposition to quarry

Opponents of a proposed rock quarry near Southport now have an ally in Carolina Power and Light Co., which has asked the state to deny a mining permit to Martin Marietta Aggregates.

CP&L officials say a mine built just north of the twin nuclear reactors would constitute a "substantial physical hazard" to the power plant and its neighboring industrial buildings.

In a letter delivered Friday, CP&L president William Cavanaugh III requests that the N. C. Department of Environment, Health and Natural Resources turn down the project. He says the mine would threaten the operation of the plant.

The announcement was a blow to Martin Marietta, which had been trying privately to ease CP&L's worries about the proposed mine. The site lies en a 1,000-acre tract just north of the Brunswick plant.

A key concern is the potential development of sinkholes caused by pumping water from the Castle Hayne underground aquifer to expose the 60-foot layer of limestone. CP&L's railroad spur, which crosses the Martin Marietta property, ships chlorine and spent nuclear fuel.

Cavanaugh says a Martin Marietta study on possible sinkhole development is "flawed and unreliable." Upon learning of the mining application, the utility company hired its own consultant, Edgerton Environmental Services Inc., to review the report filed by Wilson Engineering Services for Martin Marietta on October 21.

Rec director Woodward resigns from beach post

Long Beach parks and recreation director Woody Woodward resigned Tuesday night following an executive session with the town council, saying he had "family health problems" to attend to in Charlotte.

"It's just that family matters take precedent over job matters," Wood-ward explained. "A lot of times a big row is caused in personnel matters, but this is kind of the opposite. Things are going well, there's a lot of momentum and people are excited about the things we can do."

· Calling it the "most sensitive" of seven recommendations to reorganize central office instructional staff, assistant superintendent Jan Calhoun told the Brunswick County Board of Education Monday that five administrative positions should be eliminated.

The board approved the reorganization plan 4-1, with Yvonne Bright dissenting.

The plan, which would take full effect in July, 1994, would eliminate the following positions, all of which are paid with local funds: director of library and media; director of athletics, health, physical education and driver's education; supervisor of elementary

schools; supervisor of middle schools; supervisor of high schools.

Those positions are currently held by Edna Gause, Nelson Best, Christine Hall, Bob Rhyne

and James McAdams. "This is the most sensitive of recommenda-tions," Calhoun told the board, adding that he

spoke with all affected individuals last week to "take the uncertainty out" of the situation. "I really felt they needed to know what my

thinking was," he told board members.

Noting that he has come to "respect and care for" the people who are affected, Calhoun said he hopes positions could be found to match

their skills and interests.
