Dear Editor:
As I'm one of Randolph county's boys, thought I would write a sketch of my trip. I went to Camp Jackson May the 25th, 1918 with the Richmond county boys. There were 124 of us. We stayed there about one month and then transferred to Camp Sevier to the 81st division which is the Wild Cat division. We were in training there until July the 24th when we went to Camp Mills, N. Y., and on August the 5th we sailed on the ship Aquitana, a large British ship and landed at Liverpool, England, the 12th, stayed there one day and two nights and then by rail to South Heston on the English Channel, arriving there in the evening and went to a rest camp, leaving the next evening, crossing the English Channel, and arriving at La Haye, France, going to rest camp. Left camp next night at 11:30 p. m. Here where we had one to sit ride in box cars. They have small cars here with only four wheels under them. They were marked for only eight horses but they put forty of us to a car. We rode this way one day and two nights, landed at Tonneire. Then hiked about ten miles to a little village named Marie. We were in training here one month and left for the front which was the St. Die sector in the Vosges mountains. Here is where we first heard Fritz's shells. We were on this front about three weeks and went to a town, Rehaincourt and were in training here for two weeks and then to the front between Verdun and Metz. We were in the trenches here until Nov. 9th when we went over the top that morning. This is where we first realized what going over the top meant. We were in a drive until eleven o'clock, November the 11th. We boys did not know that the armistice was to be signed until ten o'clock that morning and it was the best news I think I ever heard. We almost doubted that fighting would cease at 11, but it did. Then we began to talk about going home and what ship we would sail on. We left there on the 17th and hiked three weeks, a distance of about two hundred miles to this place. We've been going home and to Germany and haven't gone anywhere yet. Can't say when we will sail but hope it won't be long. We hear all kinds of news of going home.

Hoping you all at home are enjoying good health.
