

Don't run cold milk through the separator.

Don't forget to cool the cream immediately after separation is completed.

Don't mix warm and cool cream. Don't forget to wash the separator after each separation.


Don't separate the milk without first straining it.

Don't fail to operate the separator according to directions. Don't feed dusty hay or ill-smelling

feeds just before milking. Don't expect the milk or cream to

be cooler than the surroundings where it is kept. Don't skim too thin cream.

Don't expect to get top price for cream unless cows, stable, utensils, separator, and milkers are kept clean. Don't forget that there is good money in dairying if it is properly done.
