As a test of President Coolidge's sincerity when, in his first message to Congress, he declared that "Cheaper fertilizers must be provided," Senator Walter F. George (Dem. Ga.) has prepared an amendment to the Ford-ney-McCumber tariff law looking to the elimination of the duty of \$5 s ton on sulphate of ammonia, which is one of the most important of the am-moniate group used in fertilizer.

"It is not conceivable that Congress in view of the strong statements of President Coolidge, will continue this duty of \$5 a ton at the direct expense of the farmers, when all other fertilizer materials are duty free," Senator George said, explaining his action in introducing his bill.

Notwithstanding the tariff on sulphate of ammonia much of it is im-ported, Senator George points, out, and he adds that the farmers are pay-ing the duty. The United States proing the duty. The United States pro-duces more sulphate of ammonia than is required to meet the domestic demand. The surplus is exported and sold in competition with the same foreign producers who are able to find a market here in spite of the tap-

Another Raise In Next Year's Attire

While the cold November winds were blowing, the manufacturers of ercales, cotton prints and shirtings had their minds on the warm days of

spring and summer when light clothing will again be comfortable as well as modish. That is to say, these manufacturers increased the prices on cloths to be sold for the next warm season.


