PROMINENT ERIE ATTORNEY FREED BY KIDNAPERS

Buffalo .- Jeffrey W. Sobel, prominent Erie attorney, was released unharmed at Buffalo Monday by two kidnapers who then took his car, driver's license, and car registration. The men held him up with a revolver as he was leaving a theatre Sunday night and forced him to drive them 90 miles to a Buffalo suburb, being careful to observe traffic regulations. Police believe they wanted a car and took Sobel only to keep him from reporting the theft immediately. Officers are guarding the International bridge in the belief that the kidnapers are headed for Canada.

RAIN BALKS HEAT; FLOODS THREATEN TEXAS

Chicago. - Week-end showers brought relief to midwesterners suffering from abnormal heat. Columbus reported 92, Cleveland 95 and Detroit 89 to make Chicago's 83 seem mild. Rain swelled rivers to flood proportions, especially in Texas, 4.45 inches falling at Houston and 4 inches within an hour at Robstown.




