It is no disparagement to Mr. Ewart's abilities to say that he cannot successfully compete with Mr. Crawford of the stump for the history of his party is one long catalogue of the reckless abuse of power, extravagance and inconsistencies. If Mr. Ewart would manfully throw up the sponge and declare his inability to cope with Mr. Crawford on the issues of the campaign he would do his manhood, about which he so much boasts, justice and his party no injustice because it has gone back on every pledge made to the people. Washington D. C. Oct. 10, 90.

Ex-Gov. William H. English, of Indiana, who ran on the National democratic ticket with the late Gen. Hancock in 1880 is in Washington, searching among the archives of the Government for materials to be used in a history of Indiana, upon which he is engaged, at the request of surviving members of the Convention which was held in 1850 to revise the State Constitution. Mr. English looks little, if any older than he did ten years ago, and it is certain that his history of Indiana will prove a valuable addition to political literature. Mr. English is no stranger in Washington, having been a department clerk here during the Polk administration.

Mr. Blaine has again got himself into hot water. It has been all along expected by his party workers that he would go to Representative McKinley's district and make several speeches in that gentleman's behalf, but a day or two ago Mr. Blaine stated that he regretted that pressing business would prevent his leaving Washington, as much as he would like to help Mr. McKinley, etc. This heated the blood of the McKinley republicans, and they have ever since been standing on end and hurling ugly epithets at Mr. Blaine's head. They ask how could Mr. Blaine leave Washington for three months with Congress in session, as he did this summer, without endangering the welfare of the Government, if he cannot now get away for a single week. Ewart Absent Again.

is He Getting Ready to Bolt Altogether.

Mills River, Henderson county, Oct. 9.—Ewart was absent again today. And this is his own county, too. He is so nervous that he is really afraid of his own shadow. Crawford's speech has taken such a hold on Ewart that it rides him at night as a nightmare. He cannot stand it to meet him but once in his own county. He declared that "he had business to attend to, and could not be present." He did not say what the business was, but we will just mention it for him, in order that the people may know what Ewart calls "business." When we arrived at Hendersonville today we found that Ewart had driven nearly all night last night to reach his home from Brevard, and that he had been closeted all day with R. O. Patterson and Mr. W. W. Rollins. Now it is well known what that combination meant. They were devising ways and means, particularly the means, for attempting to stem the tide which is overwhelming Ewart. The "bit" must be fried out in large quantities, and as Rollins and Patterson hold the largest offices, they must put up the most boodle. This is the "business" which prevented Ewart from meeting Crawford today. There was a splendid crowd out, however, and Crawford spoke for fully two hours, and more than one republican declared he was done with the G. O. P. for all time. One of the new converts became so enthusiastic that he made a speech to a circle of his friends immediately after Crawford closed his talk.—J. P. K.—Asheville Citizen.
