## CHRISTIAN ENDEAVOR SOCIETY'S SCHEME

To Take Initiative In Important Movement

TENTATIVE PROPOSAL.

Plan is For Amalgamation of Christian Endeavor Society, Epworth League and Baptist Union-Convention No. 5 Meets at Denver.

Denver, July 11.-A movement of signal importance in the religious world has been launched by the Christian Endeavor convention No. 5, in session here. It is a tentative proposal to work for the amalgamation of the Christian Endeavor society, Epworth league and the Baptist Union, and it will be presented in the form of a petition from the endeavorers to the other two national bodies. In taking the initiative in the advocacy of such union the Christian Endeavor Society points to its priority of establishment as justification.

"To evangelize the world," this is the keynote of the preas of the noted ministerial orators of this country, and of England, who attend the sessions of the International Christian Endeavor convention. That a definite plan for carrying on the work will be adopted before the convention adjourns is probable.

Services in churches at 6 o'clcok this morning were attended by thousands of delegates.

From 8:30 to 9:30 o'clock sessions of the Christian Endeavorer School of Methods were held in eight churches. At 10 o'clock a conference of state,

district and local union officers began at Central Presbyterian church, President Clark presiding. Address es, containing suggestions to Christ.an Endeavor workers were delivered.

Simultaneously the convention proper was in session at the largest tent in Camp Endeavor. Rev James T. Hill, of Salem, Mass., presided.

"Our Resources and How to Develop Them," was the topic of the day and addresses were made by prominent members. The latter will recognize the rights of the third wife and will live with her recovered children.

TALKED WITH HARVEY LOGAN.

Escaped Montana Pandit Seen in Atlanta, Ca

Knoxville, Tenn., July 9.-A letter received here today from L. C. Houk, an attorney of this city, who is now at Lithia Springs, Ga., states that he saw and conversed with Harvey Logan in Atlanta last Saturday. He states further that Logan enjoined him to say nothing about the meeting until five days had elapsed. He inferred from Logan's conversation that the bandit proposed to sail for a foreign country. Logan is the Montana train robber and multi-murderer who escaped from the Knox county jail June 27.

Juvenile Cracksmen Jailed.

Pensacola, July 11.-The police, after being worried for many weeks with robberies of stores, have at last succeeded in arresting the robbers. They now have under arrest five boys, two negroes and three white, none of whom are over 12 years of age. Some of them have acknowledged their guilt, giving the names of various stores which they have entered during the past six months, and also the articles taken. Music stores, dry goods houses, and other places of business have been looted. The boys had skeleton keys of a number of places, but they were never used, except on one occasion, when they entered the store of Kress & Co., on Palafax street.

Will Grade Electric Line.

Florence, Ala., July 11.-The contract for the grading of the electric railroad to be constructed between Florence, Sheffield and Tuscumbia has been awarded to T. M. Crow, civil engineer and contractor, of this city, and a large force has been put at tha work. According to the terms of the contract the work must be completed by December 1. The amount of Mr. Crow's bid could not be ascertained.

#### Mirage Seen at Apalachicola.

Apalachicola, Fla., July 11 .- A mirage was witnessed by a number of people here. A cloud over the town had a perfect representation of the bathing wharf, lighthouse and trees on St. George's island which is 7 or 8 miles from here, and are not visible except dimly to the eye, but in the mirage they appeared plainly and seemed to be quite near.

National League Meeting Called. New York, July 11.-President Pulliam, of the National League, has called a special meeting of that organization to be held in the Victoria hotel, this city, on Monday, July 20.

Peonage Case In Florida.

Jacksonville, Fla., July 9.-J. S. Bennett, chairman of the board of commissioners of Bradford county, accused by Maggie Williams of holding her in a state of peonage, was arraigned before United States Commissioner Locke, waived examination and placed under a \$500 bond, which he gave.
