Asheville Letter

The twelfth annual convention of the Commercial Law League of will have a number of prominent speakers on their list, including glary. Governor Glenn of this state, Governor Blanchard of Louisiana and Hon. John Temple Graves of Georgia. Judge Jeter C. Prichard of this city and John G. Gray of Seattle will discuss the bankruptcy laws and the address of welcome to the convention will be made by Mayor Alf Barnard of Asheville. On the first night of the convention there will be a reception and dance given at the Battery Park hotel, and this will be largely attended by members of the league and Asheville people. The visitors will enjoy a drive over the Biltmore estate during their stay and the annual banquet will be given the last night of the convention. A side trip will be made into the Transylvania section by a number of the visitors to take in the sights of that beautiful country and a short stay will be made at Toxaway Inn.

The Asheville Telephone and Telegraph Company have for the past month been actively engaged in installing the underground system for the local telephone exchange, but have been meeting with trouble from time to time by unknown parties tampering with the wires and property of the company. In one instance the culprits cut all of the wires on Atkin street, completely crippling the phone service in that section of the city. An effort has been made to ascertain who is doing this dastardly work, but without avail, so the company has seen fit to offer a reward of several hundred dollars in the hopes of capturing the miscreants.

Great preparations are being made in anticipation of the Firemen's tournament that will be held here July 10, 11 and 12. Between two and three thousand visitors are expected to be in the city at the time and the business houses will all he decorated in honor of the visitors and they will be shown a good time by all.

Mr. Lipe of Biltmore who was shot last week by his son (as stated in this cerrespondence) being mistaken for a burglar is reported to be improv-ing rapidly.

This city has been visited by a number of nervy sneak thieves recently, and a number of houses have been reported to have been entered. It is evident that the work is being done by one person or a well organized gang. All of the thefts reported have been perpetrated in a like manner. The houses are entered at the dead hour of the night, entrance being usually effected through a basement or rear kitchen window. The robber prowls the whole house regardless of people who are asleep in the rooms. In addition to several robberies which have been successful a number of attempts have been made to enter houses and the thief had been scared away. On one occasion in the residence of Mr. Shehan on South Main street the man was discovered by the owner of the house but as it was very dark he was at first mistaken for a boarder and was allowed to gain the stairway and make his escape before anything could be done. Mr. Shehan in conversation with your correspondent stated that the man was a light mulatto of medium build and that he had gone out into the hall to awaken a young man boarder for some purpose and nearly walked over the negro in the hall, who was in the act of going thro' a trunk at the time. 
