Again Declared to Be Unbearable by Official Body.


When Judge Henry P. Lane on Wednesday adjourned the November term of the Superior court for this county he announced that he would be back Friday morning to resume the sessions of the court. but he failed to return. Instead he telephoned that he was indisposed, and instructed Clerk of the Court Paxton to formally terminate the term.

When the judge and solicitor left Brevard Wednesday afternoon the grand jury was still in session, and this body did not complete 'its business until Friday morning. The report of the grand jury was turned over to Clerk Paxton, and is as follows:

"To his Honor Judge Lane, presiding:

"We the grand jury named for this term of the court beg to submit the following report:

"First: The county home. We have, by committee duly appointed, examined the county home for the aged and infirm and find that the number of members in the home is five, who seem to be reasonably well fed and clothed. Sanitary conditions are as good as could be expected with the present conditions of the home. Now we as your grand jury find the county home in a deplorable condition, such that we deem it impossible to keep the inmates of said home in a comfortable condition owing to the cold winds that pass through for lack of proper fitting doors, windows, plastering and floors, and we as your grand jury ask your honor to make a special order that the home be made comfortable and safe at once, and as it has been asked for heretofore and the commissioners have failed to comply with the request. "Second: The jail. We have as a jury examined the county jail and find it to be in as sanitary condition as present arrangements will admit and that the inmates are properly cared for. "Third: The county offices. We find that/the'county offices are in good condition. We recommend that the necessary chairs be provided for and also that broken lights be replaced, also that the outside of the court house be cemented for protection of same. We also recommend that the sheriff be requestof the road will be received with ed to keep the public property inside the court house grounds. "Before closing our report we desire to thank your honor for your kindness to our body, and for your clear and instructive charge.

Since the establishment of this service there has been a very noticeable increase of teaffic.
