BARACAS IN CHARGE

RECORDER'S COURT

Only four cases came up for consideration at the session of the recorder's court last Monday, and as there were no lawyers employed to defend three of them, the court session did not last long.

A case of the State vs. Birch McGaha, charged with obtaining credit under false pretenses, excited the sympathy of the court and all the spectators. It seems that while McGaha was sick he signed, or made his mark upon a chattel mortgage for the purpose of paying his doctor. The mortgage was upon a yoke of cattle that did not belong to him, and that when the time to pay up came around he could not meet the obligation and the holder of the mortgage could not secure the cattle. After hearing all the evidence in the case, the court declared him guilty, with judgment suspended upon payment of costs, whereupon all the court officers announced their willingness to give him their costs, and a friend of the accused in the court room gave him the money to pay the other costs.

When the case of the State vs. E. C. Ward, charged with bigamy, was called the defendant waived examination and was bound over to Superior court under a \$1000 justified bond.

Edward Wood, one of the Breemen connected with the Western Union Telegraph crew now working on this line, was charged with public drunkenness and resisting an officer. He entered a plea of guilty in both cases, declaring that he was so drunk that he did not know that he had resisted an officer. In the case for drunkenness he was fined \$25 and costs, and in the case for resisting he was fined \$25 and costs, the judgment of the court being that if the fines were not paid he should be sent to the roads to work it out. The defendant in this case, as usual, declared he did not know the man who sold him the whiskey.

CHARLESTON MAN KILLED

Sidney J. Cohen, a newspaper reporter on the Charleston Evening Post, was shot and killed by some party unknown while the executive committee was counting the votes in the municipal election last Friday night. Fearing over the election was running high, and the votes were very close, and to prevent bloodshed the militia had been held in readiness for serious trouble since the previous Monday.

The fight that resulted in the death of Cohen started in the committee room, and in the general exchange of shots that followed four other men were wounded, two of them seriously.

Tristram T. Hyde has since been declared the nominee for mayor, and as a nomination is equal to an election no further trouble is expected. Mr. Hyde is well known in Brevard, having spent several weeks here during the past summer.
