CHANCES IN SCHEDULE

Sunday, October 24th, the Southern Railway will inaugurate its new and much improved service to and from the east.

On Sunday number twelve's schedule will be changed and this train which now leaves Asheville at 2:25 p. m. will leave at 2:35 p. m. (eastern time), arriving from the west at 2:15 p. m. instead of 2:05 p. m., present schedule.

Number twelve leaving Asheville will have a through sleeping car for Washington, Baltimore, Philadelphia and New York, also an additional sleeping car for Washington, also a cafe-parlor car between Asheville and Salisbury.

Southbound, the through service will arrive at Asheville on No. 15, the New York and Washington sleeping cars and the cafe-parlor car all being on this train.

This new service gives to Western North Carolina a much improved service both as to arrivals at Asheville and New York, and the inauguration of the cafe car service gives ample dining car facilities.

Train No. 11, arriving Asheville 2:40 p. m., which formerly handled the New York Asheville sleeping car southbound, will after this date have a Pullman chair car between Salisbury and Asheville, but will not have any through sleeping car service. Train No. 15, departing from Asheville at 6:15 p. m., which formerly handled the Asheville-Washington sleeping car will handle a Pullman chair car between Asheville and Salisbury.

The Norfolk-Asheville sleeping car will on this date, be changed to Charlotte-Norfolk sleeping car.
