GEN. GORDON CRITICISED FOR ANTI-ALLIANCE TALK.

ATLANTA, Ga., Sept. 10.—The democrats of Schreven county in a mass meeting held at Oliver, the county seat, unanimously passed resolutions endorsing Norwood for the United States senate. The resolutions score Gen. Gordon for his fight on the sub-treasury and his failure while fighting it to suggest anything better. They then commend the recent utterances of ex-Senator Norwood. One paragraph of the resolutions adopted shows the drift of the whole. That paragraph reads:
"Resolved, That Brother Alf's religion, Uncle Joe's money and Gen. John's war record be relegated to the unbragging perennial where in sweet communion they can realize the delectableness of living under an administration where Cincinnati holds the gubernatorial plow. Agricola is a prominent factor in the legislative halls, and our Tom is opposing corruption in congressional debates, and listen to the dulcet strains of our buoyant farmers as they harmoniously sing:
'Cotton in the ball,
Money in the pocket,
Baby in the cradle,
And a pretty wife to rock it.'"
The references in the first lines of the paragraph are to Alfred H. Colquitt, Joe Brown and Jno. B. Gordon.
Gen. Gordon was endorsed by Hall county to-day.

JOLLY EDMUNDS.

How Sarcasmic He Can Be—Vance Will Give Him.

WASHINGTON, Sept. 8.—Senator Edmunds has a habit of dictating to the senate what it should do and should not do, and is very much given to fault-finding when senators disobey any of the small rules for the government of the senate chamber. He is at times, however, very unkind of his own behavior and repeatedly does things which he would quickly resent coming from another senator.
During the first night session of the senate on Tuesday, Mr. Edmunds, from some cause or other, was in a very jolly mood. He spent much of his time in the cloak room in lively conversation and went in and out of the chamber constantly. During the speech of Mr. Vance Mr. Edmunds, whose seat is in the front row of the republican side, was surrounded by several colleagues, and together they made so much noise with their laughter and loud talking as to attract general attention and create much disorder. When Mr. Vance finished his very interesting speech Mr. Edmunds, in his rasping voice and sneering manner, made the following little speech, which was none the less ill-tempered because it was delivered with an ice-cold Vermont smile:
"Mr. President, I believe the county of Buncombe is still in the state of North Carolina. I have some observations to submit on this question that has been so instructively discussed by my friend from North Carolina, but it is rather late, and I accordingly move that the senate adjourn."
The senate thereupon did adjourn, for it could never decline to do what Mr. Edmunds tells it to do, unless Matthew Stanley Quay happens to desire it to do something else.—New York Sun.

VANCE AND THE FARMER.

The Later Cannot be Deceived Much Longer.

From a Speech in the Senate.
It is useless to deceive him [the farmer] or try to deceive him any longer with protective duties on eggs and split beans and cabbage heads and dried apples. It is useless to bait him any longer with free fiddling, skeletons, acorns, salted guts, nutmegs, and Zaite curries. Tempting as this bait is, the farmer prefers to have cheap ties for his cotton and twine for the sheaves of plenty which he reaps from the earth, than cheap trace chains to pull his plow and fence wire to inclose his fields, cheap blankets, cheap bagging for his cotton, cheap tinware for his household and cheap window glass for his house.
Look over that free list, Mr. President, and no impartial mind can see a single solitary article which is largely imported of any particular benefit to the farmer in his business. He will see every one of them either for the benefit of the rich or for the benefit of the manufacturer. That is not right, sir; it is not just, sir; it is almost, I was going to say, impetuous, it is to thus oppress men who, as the instruments of the Almighty, answer for the prayer He taught us to utter: "Give us this day our daily bread."

REED IN RECLUSION.

He is in Washington But Not in the House.

WASHINGTON, September 10.—Speaker Reed reached Washington this morning and appeared at the capital about 11 o'clock. He went at once to his room, where he has since remained, seeing no one. It was expected that he would take his seat in the chair at the opening of the session, but he did not respond to the summons of the doorkeeper, and Speaker pro tem Burrows called the house to order.
A magnificent floral design adorned Speaker Reed's desk this morning. It was composed of roses and smilax bordering a large shield of white immortelles, on which was inscribed in blue immortelles the word "business." Surrounding the whole is an immense gavel of white immortelles indicative of power with emblem of roses and smilax, which is emblem of authority. It was the gift of the enrolling clerks of the house.
Just before the hour of noon a page appeared bearing in his arms the emblem of the State of Maine—a pine tree, surrounded by a small American flag and placed it on the speaker's desk.
The house was called to order by Speaker pro tem Burrows after which Mr. O'Ferral, of Virginia, raised the point that there was no quorum present. The speaker pro tem being unable to count a quorum Mr. Hanger, of Wisconsin, moved a call of the house.

THE TEUTONIC WON.

She Beats the City of New York—Depew Home.

NEW YORK, Sept. 10.—The White Star steamer Teutonic came in a winner today in the great ocean race with her rival of the Inman Line, the City of New York. The Teutonic passed Daviet's rock light ship, Queenstown, at 3.11 p. m., the 4th inst., and arrived off Sandy Hook light at 7.50 this a. m., making the run between the two points in 5 days, 20 hours and 54 minutes.
The best previous run of the Teutonic between the same points was five days, sixteen hours and fifty minutes. The best run of the trip was made yesterday—509 miles.
Archbishop Corrigan and Chauncey M. Depew were passengers on the Teutonic.

DIVIDED REPUBLICANS.

None in Kansas Go With THE DEMOCRATS.

Prohibition Denounced as Not Being a True Temperance Measure, and as Preventing Control of the Liquor Traffic.

WICHITA, Kan., Sept. 10.—Three hundred delegates attended the resolutionist republican convention. The platform was prepared after consultation with the committee on resolutions of the democratic convention. On the question of prohibition it says:
"We arraign the party managers in this state as disloyal to the principles and unfaithful to the interest of the republican party. This thing impels us, as the only method which promises success, to sink party preferences and unite with such of our fellow citizens of the state as share our convictions, without regard to party, for the purpose of correcting the follies into which we have been betrayed."
"We are opposed to prohibition. Ten years trial has demonstrated its total inefficiency as a temperance measure. The existence of a prohibitory law is a perpetual menace to the material interests; it burdens us with taxation, and it deprives us of all control of the liquor traffic and revenue therefrom."
The platform further declares in favor of high licenses and strict laws and regulation of liquor traffic.
The democratic convention was called to order by Edward Carroll. The committee on resolutions appointed a sub-committee to meet with a like committee from the resolutionists on resolutions.
The two conventions fused on a ticket which is headed by ex-Governor C. E. Robinson, a resolutionist.

COTTON AVERAGES.

Fair Condition of the Crop Reported.

WASHINGTON, Sept. 10.—The statistical returns to the department of agriculture for September, show a less favorable situation for cotton than those of August. On the Atlantic coast rains following a season of drought caused rust and shedding leaves and fruit. The local returns from North Carolina show that the average condition is but slightly lowered because of the heavy rains and cool night. The high condition of Tennessee is well maintained and the crop is still growing and fringing. In Mississippi the rains in late August and early in September, caused a local injury, not so severe however as in the more eastern states. Louisiana reports improvement and the average condition for the state is higher, notwithstanding some local reductions. The Arkansas average is also slightly advanced. Texas has suffered from the drought in the central and western counties which was reported last month. The general average is reduced from 89.5 to 85.5 which is a fraction lower than the record of September, 1889.
State averages: Virginia, 93; North Carolina, 95; South Carolina, 87; Georgia, 86; Florida, 90; Alabama, 84; Mississippi, 87; Louisiana, 93; Texas, 77; Arkansas 89; Tennessee, 94.
There is very little mention of the cotton crop, but the fall worm is unusually prevalent and active from Georgia to Texas and more injurious in the more western portion of the belt.

ON CAPE FEAR.

A Steam Yacht Lost—Passengers Saved.

WILMINGTON, N. C., Sept. 10.—The American steam yacht Meguon, Capt. D. H. Pugh, of New York, to Savannah, grounded at 8 p. m., yesterday on the extreme point of the Cape Fear. The vessel is a total loss. The crew of five, including the captain were rescued by the Cape Fear life saving crew.

A Model Wife.

BERLIN, Sept. 10.—Count Raventlow, President, and other Schleswig dignitaries, gave a banquet to Emperor William at Glucksburg. Replying to toasts, the emperor expresses his gratitude to Schleswig for the gift of the new town at his side. The emperor, he said, was a model wife, who, more than any one else, helped him to fulfill joyfully his tasks as sovereign.

The Cholera Decreasing.

MADRID, Sept. 10.—Fifteen fresh cases of cholera and eleven deaths from the disease are reported in Valencia city. Throughout the province of Valencia and elsewhere the disease is decreasing.

Tariff Bill Vote To-Day.

WASHINGTON, Sept. 10.—In the senate to-day the tariff bill was taken up, the question being on its passage, and six hours being allowed to close the discussion, after which a vote is to be taken.

What a Record Did.

PORTLAND, Ore., Sept. 10.—The second enumeration of Portland and Multnomah county gives a population of 75,237 a gain of 14,260 over the former enumeration.

For Cleveland.

ST. PAUL, Minn., 10.—The democratic state convention nominated for governor Thos. Wilson, of Winona, and commended Grover Cleveland.

Another Strike.

FINDLAY, Ohio, Sept. 10.—The brakemen employed on the Toledo, Columbus & Cincinnati railroad here, went out to-day on account of wages trouble.

SHOT AT AS RIOTERS.

SERIOUS TROUBLE AT SOUTHAMPTON.

Strikers Defy the Local Authorities and are Dispersed at the Point of the Bayonet—The Mayor Resigned.

SOUTHAMPTON, Sept. 10.—The strikers made a riotous demonstration last night and were only dispersed at the point of the bayonet.
The trouble began with the dock laborers preventing the departure of the trains. The strikers also besieged the gates of the dock and prevented the entrance of the officials. Two companies of infantry arrived in the evening and drove the mob away from the rails. The dockmen made some desperate attempts to break the line formed by the troops. Some of them took horses from cabs standing near by and mounting charged furiously upon the soldiers. The troops, however, stood firm and repeatedly repulsed the strikers. A number of horses were bayoneted and some of the riders were seriously wounded. By this time the crowd had been greatly augmented and volley after volley of stones were hurled at the troops. One lieutenant had the bridge of his nose broken by a stone, and two others were severely injured.
At this juncture the mayor appeared upon the scene and read the riot act. This only added to the fury of the mob, a section of which stormed the mayor's business premises and smashed every window in the place. The troops were now supplied with ball cartridges, each man receiving twenty rounds. The mob still keeping up the attack, the soldiers were ordered to charge, and the whole line advanced upon the crowd with fixed bayonets. For a moment the mob made a show of resistance, but seeing many of their number fall, pierced by the bayonets of the soldiers, the mob broke and fled in wild disorder.
The excitement throughout the city last night was intense and further trouble is feared.
AFTERNOON.—Striking dock laborers, sailors and firemen at Southampton maintain a menacing attitude and the authorities fear that there may be rioting, notwithstanding the fact that a large force of police from London and other places are here for the purpose of aiding the local authorities in preserving order. Further detachments of troops have been summoned to assist in putting down any overt demonstrations that the mob of strikers may attempt.
Some of the strikers have gone out in small boats to await the arrival of the incoming steamers with the object of persuading their crews to join in the strike.
The admiralty has been asked to assist in preventing this move of the strikers.
Eight men were arrested for taking part in rioting yesterday. To-day the mob gathered about the mayor's residence and made threatening demonstrations. The mayor telephoned for assistance and a number of soldiers were dispatched to disperse the crowd.

A Tornado's Work.

GOSHEN, Ind., Sept. 10.—A tornado visited Clinton township yesterday and did immense damage, wrecking fences and trees, destroying crops, blowing down houses, barns, etc. All the buildings on Stanbury's farm were leveled to the ground. The loss will be great.

Returns From Maine.

LEWISBURG, Sept. 10.—The Journal has returns from 285 towns for governor, giving Burleigh 52,150; Thompson 35,388; Clark 1,844; scattering 268. Republican plurality, 16,763. The same towns in 1886, the last "off" year, gave a republican plurality of 12,721.

The Price of Silver.

WASHINGTON, Sept. 9.—The amount of silver purchased at the treasury department yesterday was 255,000 ounces, as follows: 70,000 ounces at \$1.17.2; 50,000 ounces at \$1.17.4; 135,000 ounces at \$1.17.28.

Robert Garrett III Again.

NEW YORK, Sept. 10.—Robert Garrett is very ill again with his old trouble at Aachen, Switzerland.

AFFAIRS OF CONSEQUENCE.

FOREIGN.

The Belgian labor party has decided to declare a general strike on the occasion of the meeting of the labor congress in Belgium, September 14.
The recent fire in Salonica, Turkey, caused by the bursting of a spirit still, burned over an area of 250 acres, destroying property on which \$1,000,000 insurance had been placed, \$750,000 of which is held by British companies.
During their stay at Kissenegg the Duke of Edinburgh, one of the sons of the Queen of England, showed his admiration for Prince Bismarck to the extent of begging the German statesman to give him as a present the pipe he smoked.
HOPE.
Nine breweries in Boston and vicinity have been discovered by a government measurer from Washington to be using over-sized packages.
The thermometer rose to 92 degrees above zero at New Brunswick, N. J., Saturday, and several large factories closed on account of the heat.
All crops in Ramsey county, North Dakota, that were spared by the drought and ready for harvesting were utterly ruined by hail Friday night.
Hon. Sumner Howard, who as district attorney of Utah, secured the conviction and execution of John D. Lee, the noted Mormon leader in the Mountain Meadow massacre, is dead.
The re-election of Speaker Keed by the largest majority he has ever received, means a defeat for Mr. Blaine, and that to a certain extent, the Blaine following that has controlled the politics of Maine for years past, has been ignored.
The Lincoln independent republican club, of Philadelphia, has issued an address signed by fifty-six leading republicans, declaring that the defeat of Senator Quay's candidate for Governor is essential to reform in the republican party.
The republicans of the second congressional district of South Carolina have nominated Smith, colored, as their candidate. This district is represented by George D. Tillman who will probably have opposition in his own party to his nomination.

WASHINGTON, Sept. 8.—Senator Edmunds has a habit of dictating to the senate what it should do and should not do, and is very much given to fault-finding when senators disobey any of the small rules for the government of the senate chamber. He is at times, however, very unkind of his own behavior and repeatedly does things which he would quickly resent coming from another senator.
During the first night session of the senate on Tuesday, Mr. Edmunds, from some cause or other, was in a very jolly mood. He spent much of his time in the cloak room in lively conversation and went in and out of the chamber constantly. During the speech of Mr. Vance Mr. Edmunds, whose seat is in the front row of the republican side, was surrounded by several colleagues, and together they made so much noise with their laughter and loud talking as to attract general attention and create much disorder. When Mr. Vance finished his very interesting speech Mr. Edmunds, in his rasping voice and sneering manner, made the following little speech, which was none the less ill-tempered because it was delivered with an ice-cold Vermont smile:
"Mr. President, I believe the county of Buncombe is still in the state of North Carolina. I have some observations to submit on this question that has been so instructively discussed by my friend from North Carolina, but it is rather late, and I accordingly move that the senate adjourn."
The senate thereupon did adjourn, for it could never decline to do what Mr. Edmunds tells it to do, unless Matthew Stanley Quay happens to desire it to do something else.—New York Sun.

VANCE AND THE FARMER.

The Later Cannot be Deceived Much Longer.

It is useless to deceive him [the farmer] or try to deceive him any longer with protective duties on eggs and split beans and cabbage heads and dried apples. Look over that free list, Mr. President, and no impartial mind can see a single solitary article which is largely imported of any particular benefit to the farmer in his business. He will see every one of them either for the benefit of the rich or for the benefit of the manufacturer. That is not right, sir; it is not just, sir; it is almost, I was going to say, impetuous, it is to thus oppress men who, as the instruments of the Almighty, answer for the prayer He taught us to utter: "Give us this day our daily bread."

REED IN RECLUSION.

He is in Washington But Not in the House.

WASHINGTON, September 10.—Speaker Reed reached Washington this morning and appeared at the capital about 11 o'clock. He went at once to his room, where he has since remained, seeing no one. It was expected that he would take his seat in the chair at the opening of the session, but he did not respond to the summons of the doorkeeper, and Speaker pro tem Burrows called the house to order.
A magnificent floral design adorned Speaker Reed's desk this morning. It was composed of roses and smilax bordering a large shield of white immortelles, on which was inscribed in blue immortelles the word "business." Surrounding the whole is an immense gavel of white immortelles indicative of power with emblem of roses and smilax, which is emblem of authority. It was the gift of the enrolling clerks of the house.
Just before the hour of noon a page appeared bearing in his arms the emblem of the State of Maine—a pine tree, surrounded by a small American flag and placed it on the speaker's desk.
The house was called to order by Speaker pro tem Burrows after which Mr. O'Ferral, of Virginia, raised the point that there was no quorum present. The speaker pro tem being unable to count a quorum Mr. Hanger, of Wisconsin, moved a call of the house.
