A NEW ENTERPRISE.

Kopp and Litchenerger will
manufacture medicines.

Asheville is to have a patent medicine
manufactury.

C. R. Kopp and George A. Litchenerger,
who came to Asheville several months
since and entered the grocery business
for sometime, since the sale of that business
been making preparations to begin the
manufacture of a number of proprietary
medicines and operations are to be
commenced immediately. Their establish-
ment will, for the present be situated
on Park street, near the end of the Pat-
ton avenue street car line and in Pro-
pect Park.

The medicines to be made up five in
number. They are: Sunginine for the
blood, Baby's Friend, Atlas Liniment,
Kopps Liver Pills and Electric Worm
Syrup. These goods are prepared from a
formula of Mr. Kopp, who manufactured
them very successfully in York, Pa., be-
fore coming here. He built up a good
wholesale trade in them among the drug-
ists of the north.

The gentlemen interested in the manu-
facture had intended to wait until spring
before beginning operations, but the press
of orders has necessitated the establish-
ment of a temporary laboratory. They
will in the spring of 1891 build a factory
near the railroad. At their present build-
ing they will carry on the business to such
extent as orders render necessary and
will also prepare some goods ahead. The
medicines will be prepared both in the
basement and on the ground floor of the
building. The bottling apparatus will be
situated in the basement and the bottled
goods will be shipped to the first floor
by means of an elevator which will be
wrapped and boxed ready for ship-
ment. All of the printing necessary to
the business, such as labels for the bot-
tles and advertising circulars will be done
on the premises. The owners have a
complete printing outfit, which is in the
basement. The press is to be run by steam
furnished by a small engine in which
atomized kerosene will be used as fuel. A
binder for pamphlets will also be put in.
