WAS RELEASED BY DEATH

WM. M. SHELTON DIES IN MAD-ISON JAIL.

His Trial for the Murder of Grant Tweed Was Going On at Marshall-Stricken by Heart Discase, He Dies in Five Hours.

Readers of THE CITIZEN will remember that on Friday morning of last week the trial of Wm. M. Shelton, for murder, was begun in Madison county court, in session at Marshall.

On Saturday afternoon, at the close of the second day of the trial, when court adjourned until Monday, Shelton complained that he was suffering from heart trouble. He was taken to the jail, placed in his cell, and a physician seat tor.

Shelton, realizing he was a very sick man, requested that his wife be sum moned. His request was granted. When Mrs. Shelton reached his side Shelton told her the cause of his illness and said he did not want her to think that his death, if death occurred, was caused by

fear of the outcome of the trial. Mrs. Shelton and the physician re-mained with the sick man, and did every thing possible to relieve him, but he rap illy grew worse, until about 11 o'clock when he died.

The erime for which Shelton was of The crime for which Suchan wins on taid for his life was committed on Sun-day, June 19, this year, and occurred in the road on Spill Corn cryck, Madison county, The murslered man was Grant Tweed, Shelton shooting him through the neck with a bulket from a pistol, Death ensued instantly. Death ensued instantly. The cause of the murder was in old grudge. Shelton escaped, but was captured in Greeneville, Tenn. He was extradited and brought to Marshall, where his trial began on Friday, as stired. In the pros-ecution Solicitor Jones was assisted by Moody & Leach of Waynesville and Gudger & Martin of Asheville. Shelton was defended by Gudger & Pritchard and I. M. Gudger, i.e. of Asheville. J. M. Gudger, ir., of Asheville, Shelton was about 45 years old. He

served in the Union army and was a United States pensioner. He leaves wife and several children.


