SLAYGLE LURED TO DEATH BY BELIEF IN BURIED TREASURE**Credulous Lumberman Murdered And Robbed When He Became Suspicious****ONE IMPLICATED MAKES CONFESSION****Declares Dead Man Was Killed For Years by The Man Who Killed Him**

(Special to The Citizen.)

NEWPORT, Tenn., Sept. 2.—Suffering the tortures of the damned and harassed by questions which he could not answer, John Cash, who is under arrest for the murder of A. J. Slagle, broke down yesterday afternoon and made a confession. Sheriff Hartwell and Justice Charles Hughey were instrumental in securing the confession which was made after repeated attempts to secure a statement. Cash is a boisterous man of 24 appearing to be much younger than he is on account of his size. He is a nephew of Dan Brooks Spencer, the principal murderer of Slagle, married the adopted daughter of Brooks and all of them live together at the Brooks home, two miles from Bridgeport.

The murder occurred Tuesday night of last week near the Brooks home. Slagle and Spencer were partners in an imaginary pot of gold, which Spencer claimed to have found and concealed under the floor at Dan Brooks. The "gold" consisted of very old Spanish coins amounting to \$200,000 or more. Spencer told Slagle that if this money was put in circulation in this country it would arouse suspicion and perhaps cause an investigation, and they decided that Slagle should raise sufficient money to pay his expenses to New York where he would exchange the Spanish gold for United States money. Slagle was to receive half the proceeds for his work. Slagle believed firmly in the story of the hidden treasure as did his wife. None of their friends, however, were intrusted with the secret, though Slagle confided in several intimate friends the information that he was soon to come in possession of a large sum of money. So sure was he of this that he offered to donate \$25,000 each to two Bristol colleges and made arrangements

HALF A CITY IS WIPE OUT BY THE FLOODING OF THE SAN JUAN RIVER**Heavy Loss of Life Follows Flood in City of Cuernavaca, Mexico.****THE POOR SUFFER**

(By Associated Press.) DURHAM, N. C., Sept. 2.—A speech received by the mayor of Nuevo Laredo, Mexico, tonight from Cuernavaca, Mexico, situated 150 miles from this city on the lower Rio Grande stated that as a result of the flooding of the San Juan river due to the recent heavy rains and the overflow from the Santa Catarina river, which is tributary of the San Juan, half the city has been washed away and there is great suffering among the poor Mexicans. The statement states that fully two hundred indigent Mexican families are homeless and both in need of food supplies. There is no mention made of any loss of life so it is assumed that up to the flood at Monterrey, which claimed such a large number of victims, the inhabitants of Cuernavaca had ample warning and were enabled to escape to high ground and save themselves. Cuernavaca consists principally of an aggregation of small adobe houses. It is a town of approximately 1,000 inhabitants and is located about three miles inland, almost directly opposite the town of Rio Grande city, on the Rio Grande river.

At Last.**RELIEF WORK OF MONTEREY, MEX., PROGRESSES AS BODIES DECAY****The Stench Arising from the River Gives Rise to the Fear That Much Sickness Will Result—The Red Cross Society Gets in Its Usual Good Work for the Sufferers.**

MONTEREY, Mexico, Sept. 2.—As communication is gradually restored with the flood-swept section of Northern Mexico, previous reports as to losses of life and property are confirmed.

Prelated dispatches received at the headquarters of the third military zone in this city today tell of damage to the town of Rayones and Gobernacion and of the practical destruction of the towns of Meir, General Bravo and Carrizago. Meier reports its damage at Victoria, the capital of the state of Tamaulipas and other towns along the Tampico branch of the Mexican Central railroad, *yo the southeast* of this city, have also been received.

Frequent meetings were made today in the relief work in Monterrey and the refugees are being taken care of as well as possible. Much money has been received from all over the public and the United States,

between Monterrey and Saltillo for at least one month. Communication will be maintained by way of the Paredon branch, which was opened this afternoon and the first train for Mexico City, which has left the town since August 26, left tonight.

The International to Reata, was reported clear this afternoon.

A regular schedule is being maintained between this city and Laredo and supplies destined for relief are now coming in.

RED CROSS WORK.

United States Consul General Philip C. Hanna has been appointed head of the Red Cross society in Mexico and will act in connection with the Mexican Red Cross society. Through his efforts all goods intended for relief purposes will be admitted free of duties when consigned to him. The railroads will also transport goods of this class free of charge.
