Such Was Object in Placing Witnesses on Stand at Hines' Instigation

COMMITTEE TO REST FOR NEXT TWO WEEKS

Committee Will Continue Sessions in Washington Instead of Chicago

WASHINGTON, July 1.—After hearing a few witnesses suggested by Edward Hines, who played a disputed part in the election of Senator Lorimer, the senate committee investigating that election today took a recess until Thursday, July 13.

Chairman Dillingham, of the investigating committee, turned over to the attorneys for publication in the record, copies of all the official telegrams sent to Hines by Lorimer while in the house or senate.

Miss Frances Carroll, telephone operator in the office of the Edward Hines Lumber company, Chicago, and Fred Carney, of the Carney Lumber company, Marinette, Wis., were leading witnesses today.

Miss Carroll declared that she overheard the long distance talks Mr. Hines had with Senator Lorimer.

SAN FRANCISCANS PANIC-STRICKEN BY TWO QUAKE SHOCKS

Jarred Central Portion of California and Nevada, But Only Trivial Damage Has Been Reported—Buildings Depopulated in 'Frisco

SAN FRANCISCO, July 1.—Two earthquake shocks, the heaviest since the big quake of 1906, and separated by only a few seconds jarred the central portion of California and western Nevada today.

One peculiar feature of the earthquake was that it did not appear to follow the old "fault" in the earth's crust which have been the playground of tremors in the past but extended from the sea coast eastward to the Sierras, including Alhambra, except areas. It was felt to the northward of Sacramento in the Sacramento valley, southward as far as Fresno, and to the east to Carson and Reno, Nev., the latter place experiencing the heaviest shock in its history.

Herbert Hadley, a lodging-house inmate, fell dead of fright, and some cases of hysteria or of cuts or bruises suffered in the semi-panic which prevailed at the hospitals.

San Jose, another heavy sufferer in 1906, reported that the shock today was the severest experienced since that time, but it did no serious damage.

WORLD'S BEST AMATEUR ATHLETES BREAK RECORDS RIGHT AND LEFT

Forbes Field Championship Games Most Successful in Its History—New Marks Set for Half Mile, Mile and Javelin Throw and Record Equalled for 220 Hurdles by Man Who Made it Before

PITTSBURG, Pa., July 1.—Three senior records were broken and one equalled today in the second and final day meet of the Amateur Athletic union championship games at Forbes field.

From every angle the contests today were exceptionally good. It is estimated that 15,000 spectators, if not more, crowded about the stadium at Forbes field to witness the seniors' performance.

Many persons were unfamiliar with the game of throwing the javelin and much interest was manifested. O. F. Sneedgar, of the Olympic club, San Francisco, hurled the shaft for a distance of 165.21 feet, breaking the American record.

Four men had tied with six feet one inch, and to decide third position jumped again. At this juncture Burdick, of Pittsburg, cleared the bar at six feet three inches, equaling the first man and beating the second, but going to third place under the rules.

Previous to the beginning of the contests today, Gov. John K. Tener, of Pennsylvania, together with several hundred representative Pittsburgers held a reception at the Pittsburg Athletic club, and met the A. A. U. officials, well known athletic trainers and some of the competitors.

EVERY EXPRESS CO. IN UNITED STATES TO BE LOOKED INTO

Sweeping Investigation to be Made by Interstate Commerce Commission

FILE NEW TARIFFS EFFECTIVE AUGUST 1

Will Not Only Include Rates, But Practices, Revenues and All Accounts

WASHINGTON, July 1.—A sweeping investigation of all of the express companies in the United States affected by the interstate commerce laws today was ordered by the interstate commerce commission on its own motion.

Evidently in anticipation of this action by the commission practically all of the express companies with the exception of the Long Island, late yesterday filed new tariffs effective August 1, which are believed to be material reductions in rates.

The inquiry is ordered to determine whether rates, classifications, regulations, or practices or any of them, are unjust or unreasonable, or unjustly discriminatory or unduly preferential or prejudicial or otherwise in violation of any of the provisions of said act, and to determine the manner and method in which the business of said express companies and each of them is conducted.

GIVEN UP THAT HOKE SMITH HAS BEST SHOW AT SENATORIAL PLACE

Unless All Signs Fail He Will be Elected on the First Ballot

ATLANTA, Ga., July 1.—Hoke Smith assumed the duties of the office of chief executive of Georgia today for the second time in his political career, but unless all signs fail, he will within the next few weeks be occupying the seat in the United States senate formerly held by the late Alexander S. Clay, but occupied in the interim by Joseph M. Terrell. According to friends of Governor Smith there are already more than enough votes pledged to the governor and it is predicted that he will be named senator on the first ballot. While not claiming so many pledged votes, friends of Senator Terrell express confidence in the situation.
