

Checks Sent To Ex-Service Men On Day Sweet Bill Was Signed

Sum Totalling \$799,580.61 Forwarded to Disabled Men—
1,065 Checks Were Written In Advance—Number
Sent N. C. Was 27 Totalling \$21,796.40.

WASHINGTON, Jan. 1.—Announcement was made yesterday, Tuesday, by Director R. G. Chalmers-Jones, of the bureau of war risk insurance, that on December 24, the day the Sweet bill became a law by the signature of the President, the bureau mailed out 1,065 checks for compensation, totalling \$799,580.61, and representing adjustments in keeping with the retroactive features of the new law for the benefit of former service men disabled as the result of injuries or illness incurred in active service in line of duty. These checks had been written in advance and were ready for the mails the day before Christmas, the day the President signed the bill.

The largest number went to New York, which, of course, had the largest number of men in the service. The number mailed to that state was 88, and totalled \$65,885.89. The number sent to North Carolina was 27, and the amount, \$21,796.40. South Carolina drew 24, for \$19,643.33; Tennessee, 47 for \$38,137.45; and Virginia 27, for \$19,907.82.

Under the new amendment to the war risk insurance act, which has been passed by congress and which became a law on December 24, 1919, when it was signed by the President, war term insurance or United States government life (converted) insurance policies may be made payable to any of the following list of "beneficiaries":

Parent, grandparent, step-parent, parent through adoption, wife or husband, child, grandchild, step-child, adopted child, brother, sister, half-brother, half-sister, brother through adoption, sister through adoption, step-brother, step-sister, uncle, aunt, nephew, niece, brother-in-law, sister-in-law; a person who has stood in the relation of a parent to the insured for a period of one year or more prior to the insured's enlistment or induction, the children of such person; parent, grandparent, step-parent or parent through adoption of the insured's wife or husband.

United States government life (converted) insurance may now be paid at death in a lump sum or in installments for 36 months or more, at the option of the insured.

The rate of compensation for disability has been greatly increased. A comparison between the amounts formerly granted under the war risk insurance act with those provided by the new law follows:

Under the new law there is an allowance to a man temporarily totally disabled, and with no wife living, of \$5 additional for each child (in excess of one) without limit as to number.

Total and permanent disability:

NOTE—(a) Under the new amendment, if the disabled person is so helpless as to be in constant need of a nurse or attendant, an additional allowance is provided, in the discretion of the director, not exceeding \$20.

(b) Both under the W. R. I. act and under the new law, compensation for the loss of both feet or both hands or the sight of both eyes, or for becoming helpless and permanently bedridden is \$100.

In addition, the new law provides that compensation for the loss of one foot and one hand, or one foot and the sight of one eye, or one hand and the sight of one eye, shall be \$100.

(c) The new law provides that for double, total, permanent disability the rate of compensation shall be \$200.

**The new law provides that each of the impairments mentioned in (b) shall be deemed to be total, permanent disability.

Partial Disability.

NOTE—In no case is compensation payable for a reduction in earning capacity rated at less than 10 per cent.
