KLAN RULED TOWN WITH IRON HAND. WITNESSES STATE

Two Witnesses Testify That Black Masks Were Worn Once.

RAIDING PARTY IS DESCRIBED BY ONE

Klan Leader Asks for a Conference With Attorney General.

By THE ASSOCIATED PRESS. HASTROP, Va., Jan. 12.—Will H. Norworthy, Morehouse Parish pastor testifying today, in the open hearing investigation of masked band depredations in Morehouse Parish, La., during the latter part of 1922, testified that he had seen a black hooded mob, credited to the Ku Klux Klan, having slain Richard and Daniel "know no name" Norworthy, testifying as to a conference he said was held with Skipwith in the latter's home at Vinton, La., the discussion led up to the disappearance of Daniel and Richard.

Will Norworthy declared he was not a Klansman and that his conference was to discuss the community report that he had been accused of agreeing to keep \$1,500 to kill Skipwith and Dr. McKoin.

"Skipwith told me it was lucky for me that I had friends in this community," Norworthy said.

The testimony of Norworthy with the statement of Robert L. Dade and Kelly Harp that black masks were used by a Klan band on the night of the murder of the Norworths, apply last summer and the testimony of Joseph Davenport, Mer Rouge merchant, who testified of the day's proceedings.

Dade said he wore a black mask furnished him by Edward Ivy, a fellow Klansman, when he was picked up in Mer Rouge and asked to accompany the band on the way to the Norworthy home. He testified that a negro was operating a gambling house there where both white men and negroes gambled.

McKoin Member Party Says.

Dade said Dr. McKoin also was a member of the raiding party and that he (McKoin) was garbed in white. Harp declared he wore a black mask also on the night of the murder. He testified that party with Dr. McKoin, W. C. Andrews and Harry Newell, who testified yesterday as to being "held up" by the Klan band.

"Was Captain Skipwith there?" Harp was asked.

"I positively refuse to answer," he replied.

Harp declined to name who appointed him on a committee made up of his brother, James Davenport, and Dr. McKoin. When he refused to join the "committee," the witness said that "the man who appointed him told me he would take care of the proper authorities of the Klan."

Davenport testified at the afternoon session of the hearing.

"My family has resided in the Mer Rouge district of Morehouse Parish, Louisiana, for 12 years," Davenport asserted. "I lived in peace until the advent of the Klan. We then had to get permission from high authorities of the Klan to occupy our residence in our old home town."

Davenport was called to testify because of conferences held by citizens of Mer Rouge, Bastrop and other parts of the Klan. Davenport, having been accused of being an "anti-Klan" leader.

After a lengthy conference, Davenport said, "Captain Skipwith agreed to let the Davenport family but insisted that three other citizens, A. C. Whipple, Tom Miller and Walter Campbell, of Mer Rouge, would have to get permission from the Klan to occupy our residence."

Davenport said a series of conferences were held in an effort to restore peace and harmony in Morehouse.

"The conditions at the time were bordering on chaos," he said. Conrad McDuffy, the last witness of the day, told of having seen a light automobile, described as a Buick, on the night of August 24—the date of the kidnaping of Daniel and Richard—returning from Lake LaFourche from which the headless and mutilated bodies of the two men recently was taken.

McDuffy and Marshall Mott, who also has been summoned as witnesses, were reintroduced from Morehouse at the time, according to McDuffy's testimony and were within two miles of the lake when the truck, driven by a man appearing to be a black hood, was seen. Another automobile was following the truck, he said. McDuffy testified its occupants also were masked.

McDuffy said Mott's following day role in his automobile with a man and his wife, whose automobile had broken down on the Lake LaFourche road, to Haysville.

Conference With Prosecution.

"The automobilists asked Mott," the witness said, "what did they do with those who had bound and gagged in the truck last night. Mott told him he did not know anything about it."

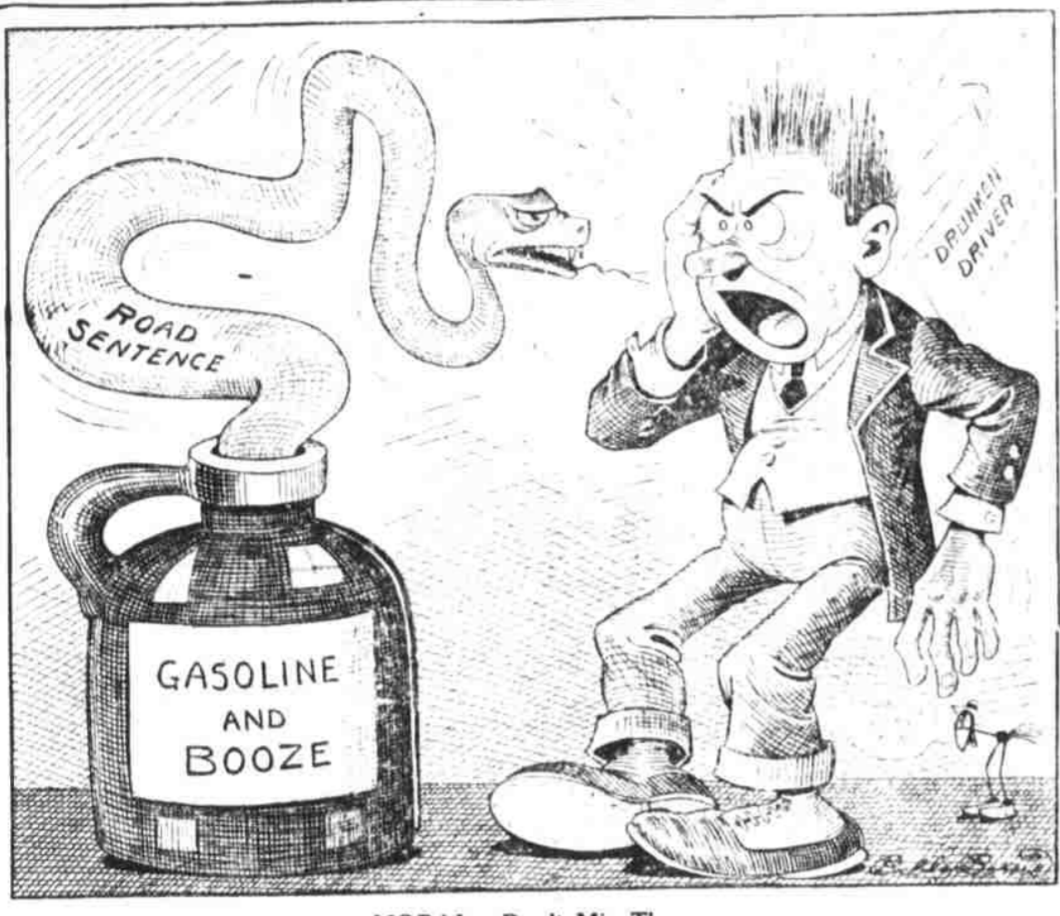
At an early hour today had fixed a conference with the Attorney General A. V. Coco and Captain Skipwith, which was requested by the latter early today. It is probable that it will be held tomorrow.

Reports were current here early today that Skipwith had made an open threat against the Attorney General. Mr. Coco in a statement to The Associated Press denied that the report was true.

The conference requested by Skipwith is to allow him to lay before the Attorney General the various operations of the Klan during the last year, he says, in order that the organization could prove no black masks were ever worn by its members.

AUTHORITIES SAY THEY KNOW OF NO GREAT RUM FLEET

But Attention of Moss Is Called to the "Extensive Publicity" Given.

WASHINGTON, Jan. 12.—Federal prohibition officials received renewed interest today in press reports of the landing of large quantities of smuggled liquor on the New Jersey coast, particularly in the vicinity of Highlands. Aside from a routine letter to William H. Moss, acting director for New Jersey, asking for a report on official notice he has taken of the situation, it was declared officially that the letter to Mr. Moss called his attention to the extensive publicity which was being given the appearance of a supposed fleet of ships carrying off American channel liquor and subsequent attempts to land cargoes. Prohibition Bureau officials said they had received no reports of unusual rum shipments from their representatives in New Jersey or New York.

Confidence was expressed at prohibition headquarters in the ability of the enforcement agents in that area to handle any situation which might arise. It was learned, however, that Acting Director Yellowley, of New York, and Section Chief Appleby, of New York, had been ordered to cooperate with Mr. Moss to the utmost of their facilities.

There was no disposition to deny the existence of a certain amount of illicit beverages both across the Atlantic seaboard and across the Canadian line. Neither the land nor sea forces of the Bureau are equipped with the situation but the unanimous opinion was expressed that the enforcement operations were being efficiently conducted and were immediately in results obtained.

Commissioner Haynes conferred briefly with President Harding late today. He said later that the smuggling situation was not discussed.

AGRICULTURAL MEETING CLOSES IN RICHMOND

RICHMOND, Va., Jan. 12.—The regional conference of agricultural and home economic experts representing 12 southern states in adjourned here today. The session, which began Tuesday, was held today without selecting a place for the next annual meeting of the Federal Board of Vocational Education. Officials of the department tonight expressed satisfaction with the results of the conference and declared it one of the most important meetings of the kind ever held in southern states. It was pointed out by these officials that the broad discussion of agricultural and home economic problems brought before the board in connection with the needs of the farm communities of the South and provided a basis for an intelligent and effective program of educational work during the year.

WINSTON-SALEM, Jan. 12.—Twenty-three witnesses were introduced today by the State in the case of C. M. Sawyer and Willie E. Chatmon, charged with setting fire to a building here last August. The witnesses testified that they saw Chatmon and Sawyer on the night of the fire. Chatmon, in his direct evidence, said that at one time Sawyer showed him a can of kerosene oil in a building and that it was bought by Calvin Beck. The witness stated today Beck stated that he bought five gallons of oil for Sawyer and placed it in the front part of the store. Counsel for Sawyer endeavored in the cross-examination to present conflicts in testimony given at the preliminary hearing and the trial today and brought admissions from several youthful witnesses that they were friends of Chatmon.

Bryan Grimes, secretary of State, 1900-1901, will take place at Christ Episcopal Church tomorrow afternoon at 3:30 o'clock. Preceding the funeral service, the body of Colonel Grimes will rest in state in the capitol of the State until 10 o'clock this morning until the funeral hour. The funeral party will assemble at the capitol and proceed across the capitol grounds to the Christ Episcopal Church at 3:30 o'clock.

All State departments were closed yesterday and will remain closed today in respect to Colonel Grimes and the flag on the State capitol is at half-mast. By joint resolution of the members of the General Assembly which recessed today in respect to the late secretary of State, will not reconvene until Monday, Jan. 15. BRITAL MURDER OF HARVEY CASE IS DEEP MYSTERY

Body of Hendersonville Man Found in Mutilated Condition.

(By Staff Correspondent.) HENDERSONVILLE, N. C., Jan. 12.—Mystery surrounds the killing of Harvey Case of this city, who was stabbed to death by unknown parties last night. When the body was found this morning, it bore 27 separate wounds, which had the appearance of having been inflicted with a small knife and some kind of large blunt instrument. Police officials tonight are completely baffled in their efforts to obtain a clue as to the identity of the person or persons who murdered Case, and tonight they are making every effort to identify the body of the victim.
