States Offices Not In Scope Of Proposed Law- Introduced by Ramsey

A bill exempting Transylvania county from the absentee ballot law was introduced last Friday in the general assembly by Senator Ralph H. Ramsey of Transylvania county. Under provision of the bill absentee ballots will not be allowed in any primary or general election as per-tains to local offices. The bill follows:

The General Assembly of North Carolina do enact:

Section 1. That sections ,962, 5,963, 5964, 5,965, 5,966, 5,967 and 5,968, North Carolina Consolidated Statutes, and any and all amendments thereto be and the same are hereby repealed, in so far a? they relate to election of officials of Transylvania county or township or municipal officials of Transylvania county.

Section 2. That all laws and clauses of laws in conflict with the provisions of this act are hereby icpealed and the repeal shall not re-vive any election laws heretofore applicable to the election of officials described under section one of this act.

Section 3. That this act shall reply only to the election of local of li-cials in Transylvania county, that is, officials to serve the county, or cities or townships in Transylvania county.

Section 4. That this act shall be in full force and effect from and after its ratification.


