

#### Absentee Bill Passed By Assembly Applying to Democratic Primary

The voting law which pre of absentee ballots in the Democratic primary in Transylvania county has been ratified by the legislature and is now effective.

A statement by Representative Par Kimzey which is carried on the editorial page of this issue sets forth reason for his introduction of the measure. Mr. Kimzey has withdrawn his mea sure which would have caused the Dem ocrats to use the convention system in stead of the primaries. This bill was inroduced before the absentee measure, but met with considerable opposition in the county, and was withdrawn by the representative.

## **PRIVATE SALE BILI** IS NOW EFFECT

Town of Brevard Allowed Te Sell Foreclosed Property Without Advertising

A bill has been passed by the legisla ture whereby the Town of Brevard may sell at private sale without advertise nent, properties acquired through tax oreclosure proceedings.

The bill provides-That the Board of Aldermen of the Town of Brevard are hereby authorized and empowered to sell at private sale without notice property acquired by the said Town of Breward through tax foreclosure proceedings. provided, that no such property hall be sold at private sale for less than the total amount of taxes and special assessments and accrued interest thereon levied and assessed by the said Town of Brevard against such property and due the said town thereon.

Introduced two weeks ago by Representative Kimzey at the request of the town officials, the bill was passed by the house, and later given an unfavorable report by the senate committee. However, former Senator Ralph H. Ramsey, Jr., went to Raleigh and explained the measure to the committee which then gave it a favorable report, and it passed the upper house last week.

The property will not be sold by the town to other than the original owner for a period of 45 days, and notice to this effect is being carried in this week's Times. However, after the 45-day period ends and the original owner has not redeemed the property, the town officials plan to sell either at private or public auction as they deem best, in order to realize tax money and other assessments from the property which has been foreclosed.

#### French Broad River Would Be Opened To **Fishing License Free**

No license will be required for fishing in the French Broad river between Rosman and the Henderson county line, if a bill is enacted into law which Representative Kimzey introduced Wednes-

The measure provides that "fishing with plain hook and line or plugs will be allowed in the French Broad river between the Pickens Highway bridge in Rosman and the Henderson county line, without license."

A bill similar, but allowing for more freedom of use of the river, and other unlicensed fishing and hunting, was introduced in 1933 by Representative Wallace Galloway, but was defeated through work of interested parties here and at Raleigh. The Galloway bill would have allowed setting of nets and traps in the French Broad, and would also have alowed hunting or fishing on property without the necessity of a license provided written permission had been first obtained from the owner of the property

**Board Commissioners Refuse To Call Transylvania Liquor Store Election** 

Transylvania county board of com-missioners by unanimous vote Monday, declared that their offices would not be used to call an election on the liquor question.

With very little discussion, the motion was made by E. Carl Allison, of Cherryfield, and seconded by John L. Wilson, of Enon. Chairman A. B. Galloway, of Brevard, who had already publicly expressed himself in the matter voted with the other two members, making the motion unanimous.

"If there are enough people in the county who want liquor stores set up. let them secure petitions to call for an election," the commissioners said in discussing the question.

The law provides that if the commissioners do not see fit to order the board of elections to call a referendum, then the way is left open by which 15 per cent of the qualified voters signing a petition to the board of elections requesting that a vote be taken.

The members of the board of com-

missioners said that they had found very little sentiment in favor of the election at this time, and that inasmuch as each of them were personally opposed to liquor stores, or for that matter in going to the expense of holding an election on the question. they could see no need for it.

Rumor had it in Brevard last week that a delegation of citizens would appear before the board of commissioners Monday and request that body to call for an election, but the delegation failed to materialize.

Transylvania county voted better than two-to-one against legalized liquor three years ago when the question was carried to the polls, and general consensus of opinion here is that the ABC stores plan would also be defeated.

Haywood County To Vote The Haywood county commissioners in meeting Monday adopted a resolution calling for an election on the liquor question, to be held the latter part of April.


