That young so-and-so walking just ahead of you down the street-he made insulting remarks about the girl you keep company with. You bring to mind all sorts of knock-down-and-drag-out scenes in which you are the avenging suitor, meting out to him the two-fisted punishment he deserves.

Careful, friend! Let the light get to that film quickly, so that the picture may be destroyed before it can be developed. You are taking a picture called Hate, which will be a source of unhappiness to you for the rest of your

If you are building up in your mind a picture of love and kindness toward someone or everyone, take that exposure into your "darkroom" and develop it. You will need encouragement and succor in the years to come, and looking at that protograph you will receive strength to walk in the old paths-the paths of righteousness and

Everybody likes good pictures. Nobody likes bad ones. More important than the apparently harmless act of taking such pictures, is what the taking of those pictures does to you. Good mental pictures will develop you into the kind, friendly person you ought to Pictures of hate and revenge will make you bitter and sour at life. Eventally they will destroy you, body and soul.

STOP AT THRU HIGHWAYS

North Carolina:-"(a) The State Highwith reference to highways under their jurisdictions are hereby authorized to lesignate main traveled or through highways by erecting at the entrance thereto from intersecting highways signs notifying drivers of vehicles to come to a full stop before entering or crossing such designated highway, and wherever any such signs have been so erected it shall be unlawful for the driver of any vehicle to fail to stop in obedience thereto. That no failure so to stop, however, shall be considered contributory negligence per se in any action at law for injury to person or property; but the facts relating to such failure to stop may be considered with the other facts in the case in determining whether

of contributory negligence. "(b) No person operating any motor vehicle upon any path, private or public road shall cross or attempt to cross, enter upon or attempt to enter upon any hard surface or improved highway intersection the said path or road without | Money back if not delighted. first coming to a full stop: Provided,

that this shall not apply to any road entering upon or crossing such hardsurfaced or improved highway unless the road governing authority (whether state or county) controlling such highway shall erect on such road at a point one hundred or more feet from the point Section 120, Motor Vehicle Laws of of entrance into said highway, a signboard not less than four feet from ground on the right side of the road, way Commission with reference to twenty-four inches by twenty-four state highways and local authorities inches outside measurements, which shall be painted on yellow background lands: with word "STOP" in black letters eight inches high, to insure warning of the proximity of the crossing and notice to stop said motor vehicle."

In plain language, the state law re quires that you bring your car to a full Lyday's corner; then with said line, stop at any highway junction or intersection marked by a black-and-yellow STOP sign.
