

### Dr. Tyson Is Named To Head Local Cystic Fibrosis Drive

Dr. James Tyson of Brevard, Cystic Fibrosis Campaign is has been appointed chairman "Never Take Breathing for Granted."

More than 5,000 North Carolina children are now suffering with incurable lung diseases.

In making the announcement, Mrs. Morgan said, "We are pleased to have Dr. Tyson join the thousands of other volunteers in North Carolina to help bring about a better control of cystic fibrosis and other children's lung diseases by collecting funds so vital for continued research at Duke Cystic Fibrosis Center, one of the 110 major medical research centers in our country supported by the National Foundation."

Cystic Fibrosis, a pulmonary gastro-intestinal disease, is produced by a recessive gene which causes the body to produce abnormally salty sweat and a thick, gluey mucus that clogs the air passages and interferes with digestion. When two carriers of cystic fibrosis marry, chances of producing a child with C/F is 1 in 4 births. Thus, C/F is found about 1 in 1000 births.

There is no cure and no test for determining a C/F carrier at this time. Symptoms may include persistent cough, rapid breathing, and sometimes wheezing; also bulky diarrhea, failure of the child to gain weight despite excellent appetite, and "pot belly." The child may appear to be suffering from asthma, bronchitis, celiac disease, or an allergy. Cystic fibrosis ranks second to cancer as a taker of young life.

The foundation now has expanded its program to include research for other chronic lung-damaging diseases as well as the incurable and inherited disease cystic fibrosis. Children suffering from chronic bronchitis, asthma with lung damage, bronchiectasis, and childhood emphysema are treated at the 110 C/F centers supported by the National Cystic Fibrosis Research Foundation. Today's pediatrician spends 85% of their time treating respiratory problems in children.
