Several Candidates Announce, Deadline For Filing At Noon Next Monday, 25th

Round-Up Made, Primary Slated On May The 7th

The deadline for filing in the 1974 political races is set for noon on Monday, February 25th here in the Board of Elections office in the Court House.

To date, a number of candidates has filed, and several others have expressed their intentions of doing so prior to the deadline on Monday.

Local races will include the following: Sheriff, Clerk of Court and two members to the Board of Education.

Transylvania will also vote in several state and national races. Candidates for these offices must file with the State Board of Elections.

They include U S Senate, Member of Congress, Justice of Supreme Court, Judge of Court of Appeals, Judge of Superior Court, Judge of District Court and District Solicitor.

Local voters will also ballot in the State House of Representative race and also the State Senate.

The registration deadline for persons not already registered will be Monday, April 8th.

According to Mr. Burrell, the Primary Election, unless changed by the 1974 General Assembly, will be Tuesday, May 7th.

A second primary, if one is needed, will be on June 4th.

It is also announced that the deadline by which any candidate could change his party affiliation in order to run as a candidate in his new party's primary WAS November 26th, 1973.

Guidelines Cited

Farmers Have Priority For Petroleum Products

Clinton D. Owen the Civil Preparedness Coordinator for Transylvania County, has announced that farmers have priority for petroleum products under the recently announced Petroleum Mandatory Allocation Program. The guidelines state that farming and logging operations carried on for profit are eligible. Also included are activities related to animal or human food production.

Farmers, who are having difficulty in securing petroleum products from their supplier, may pick up the required forms at the ASCS Office, Room 208, Bryant Building, or the Extension Service Office in the old Post Office Building.

According to the guidelines, agriculture is to receive 100% of the required needs. In filling out the forms the farmer will be asked to do two things: 1. Certify the amount of fuel needed for agricultural use, and 2. Certify that he, the farmer, is following an emergency conservation program, which he will be asked to describe briefly.

To Assist Free Care

Local Hospital Receives \$1,027, Duke Endowment

The Transylvania Community hospital has received \$1,027 from the Duke Endowment during the past week.

In all 189 hospitals and 43 child care institutions in North Carolina and South Carolina have received \$1,869,347 in appropriations from the Duke Endowment during the past week.

Over \$107,000,000 has been received by Carolina hospitals from the Endowment since it was established by James B. Duke in 1924, according to James R. Felts, Jr., a Trustee of the Duke Endowment and the executive director of its Hospital and Child Care Sections.

The recent grants to hospitals totaled \$1,253,243 and represent a payment of \$991,081 to assist in operating expenses and \$262,162 to reimburse assisted institutions participating in information services provided by Hospital Administrative Services (HAS) of Chicago and Professional Activity Study (PAS) of Ann Arbor, Michigan. Comparative statistics on various aspects of hospital operations are compiled for each participating hospital by these two services on a monthly basis.
