ic elements in America.

Speaking of the Democratic party, the President says:

"It has witnessed the life and death of two great parties, and unless I am very much mistaken, it will witness the early disappearance of another. It witnessed the life, decadence and disappearance of the Federalist party. It witnessed the life, the increase, the demoralization, the decline and the disappearance of the Whig party.

"And then there appeared upon the scene the Republican party, first of all organized for a great and definite purpose, to prevent the spread of the institution of slavery into the free portions of the United States. That object they greatly accomplished. And then there seemed to ascend upon them the spirit of the Federalist and the Whig parties, and ever since then the increasing demoralization of the party has been evident.

"The Republican party as now constituted and leaders believe in government by the attorney and special interests. They are perfectly willing that the attorneys of the people should appear before them and plead for the rights of the people, but they are not willing that the counsels which determine action shall be participated in by the attorneys of the people.

"WIPE OFF THE BOOKS."

Candidate Hughes can see no good in any legislation that has been enacted by the Democratic party. He is a modern day example of the failure of the truth in the declaration that nothing good can come out of Nazareth. And he reaches the very heights of demagoguery when he declares that "the whole Democratic legislative accomplishments must be wiped off the books for the good of the country."

Such a declaration shows passion, prejudice and partisanship run to seed. It is an expression which should teach the people of this country that Mr. Hughes is absolutely unfitted to become the head of the government of the United States. If he were not simply mouthing words in a spirit of gasconade he reveals to the country that he has a mind of the narrowest range, for no man of real sense and width of vision would make any such declaration.

That Mr. Hughes is a reactionary is evident in the declarations which he has made in the course of the speeches he has been making during the course of the campaign. That he is endeavoring to carry favor at the same time with the Progressives is known of all men. Yet the very program of legislation accomplished under the Wilson administration has in it many things for which the Progressives declared. In his condemnation of the legislation of the Democratic party he also condemns those things which the Progressives applauded.

That remark of Mr. Hughes was one unworthy a man who pretends to have any understanding of the needs of the people. Under the Hughes (led the Republicans, if returned to power, would necessarily undo the things which have been done by the Democrats. That means that there would go by the board the Federal Reserve Bank Act, the Rural Credits Act, the Income Tax law, the Workmen's Compensation laws, the Child Labor law, the Merchant Marine law, the non-partisan Tariff Commission law, that the Federal Trade Commission would be abolished, that the eight-hour day legislation would be repealed. And taking his words of condemnation at their face value there would be a knock-out blow given the legislation for the reorganization and enlargement of the army and navy enacted by the Democracy.

The curious thing about the matter

is the fact that the Republican members of Congress by their votes showed approval of many of these laws. And even the Adamson eight-hour day law, which is now receiving the brunt of the Hughes attack, was given the vote of seventy Republicans in the House, with fifty-four against it, while the Republicans in the Senate offered no opposition. By reason of these things Hughes in condemning the legislation of the Democrats condemns the republicans of Congress for their votes for the same legislation.

We do not believe that the people want to have "wiped off the books" the wise and beneficial legislation which has been put on the books by the Democracy. It is constructive legislation of the very best kind in the interests of the people. Mr. Hughes' declaration against it simply adds to the knowledge that his voice and his influence are with the Special Interests, with Big Business and Monopoly, and against the interests of the people.—News and Observer.

ating many new advantages.

My Dear Sutton:

I wrote to Mr. Daniels as I told you, and he replied that he had added my letter to the information your committee had provided, and that it would go in with the material to be submitted to the committee on location that would presently take up the subject.

There is ample coal over at Cumock to run an armor plate mill like that at Homestead, which is one of the really big concerns of the world, for five hundred years, and at the same time take care of the domestic trade for coal.

Fayetteville is within fifty miles of the cheapest supply of coal that is to be found any place in the United States on the tidewater side of the country, access to tidewater being also considered.

Fayetteville is also situated more favorably with regard to water power for in Cumberland, Hoke, Moore and Lee are water powers that will aggregate easily fifty thousand horse power. Big Rockfish, Little River, Deep River, Haw River and smaller streams will easily make up the aggregate, and if it should be worth while I could give an extended detail of the various opportunities where power could be developed on these streams. But that is not essential just now.
