'Honorable Zebulon Weaver, 'Asheville, North Carolina. 'My dear Sir:



Chimney Rock, June 14 .-- As an example of the use of the cross as by the application of Democratic a symbol of Christian reverence, a site overlooking the Lake Lure church now under construction here, is being sought by a group of friends who advocate the erection of a giant electric cross on a mountain top. The proposal has aroused the in-

terest of visitors from all parts of the country as well as the home folks, and it is very probably that funds necessary for its erection will be easily available.

According to the plans mentioned the cross will be brilliantly lighted b y a large number of electric bulbs, which at night will shine upon the mountainsides and light the church ground, the lake and the valley below. It will stand upon a high point overlooking Lake Lure. It will cast a reflection upon the waters which will be visible to practically all residents in the community as well as guests at the hotels and boarding houses in this region. It will constitute one of the beauties of this section and be a silent reminder, many believe, of loyalty to trust and fidelity to duty.
