Forest City's beautiful new \$30,-000 city hall, recently completed, is now in use, and Friday night citizens of Rutherford county's chief town were invited to an old time "house warming," formally opening the structure.

Of Colonial Design

The city hall, a two story structure of brick and tile, is of the Colonial style of architecture. Inide its arrangement is similiar to hat of other city buildings. In addiion to the clerk's office and other cooms on the first floor, one large room has been set aside for the pubic library, and turned over to the Woman's club, which is sponsoring the library.
