BOOND SENDS WRONG MAN TO PENITENTIARY. After Serving Two Years for Jewelry Theft Proves His Innocence.

Topeka, Kan., July 25.—George Horton, sent to prison in 1910 for a crime he did not commit, has been granted a permanent parole by Governor Hodges and may be given an unconditional pardon in a short time. After serving nearly two years in prison because a bloodhound connected him with the theft of some jewelry, Horton and friends have been able to show that the young man had no connection with the robbery.

Horton was sent to prison, convicted of breaking into the jewelry store of J. Southworth, at Medicine Lodge, and taking a quantity of jewelry, a bloodhound was put on the trail to hunt down the robber. On the first trail the bloodhound failed to follow the trail but straight from the store to the house where Horton was rooming and up to the young man's room.

A careful search was made of the room, but no jewelry was found. There were some tracks on the ground beside the window which had been opened and Horton's shoes were tried in these tracks. They fitted the tracks exactly. On this evidence of the bloodhound and the shoes a jury convicted Horton of burglary and larceny.

Some months after Horton had been taken to prison workmen who were repairing the Central Hotel at Medicine Lodge found some of the stolen jewelry from the Southworth store.

Eats Food By The Ton.

Average Man of 75 Has Consumed About 1,300 Times His Own Weight.

(Foreign Exchange.) Have you any idea of the amount of food you will have eaten if you attain the age of 75, providing, of course, that you are of average height, weight and appetite?

Fifty-four tons of solid food and 53 tons of liquid—about 1,300 times your own weight! That is the take-your-breath-away answer.

The tons of bread you have consumed would equal in size a small family hotel, and a ton and a quarter would be the equivalent of butter.

If you had been a lover of bacon and were to stretch it out in single slices, four miles would be the length. Five tons of fish, and 12,000 eggs stand to your credit, while a normal cheese eater easily consumes 400 pounds.

The vegetables you have consumed would fill a train three miles long, and to that trainload you could add 10,000 pounds of sugar and 1,500 pounds of salt.

Some half ton of tobacco has been consumed in pipes and 500,000 cigarettes, by the man who has been a smoker.

The postoffice department has announced that, beginning August 15, the limiting weight of parcel post packages will be increased from 11 to 20 pounds, and the postage will be considerably reduced. This will apply to the first and second zones, a radius of about 150 miles from each postoffice. By this order it is expected that the service will be very much increased, especially by local merchants and farmers.

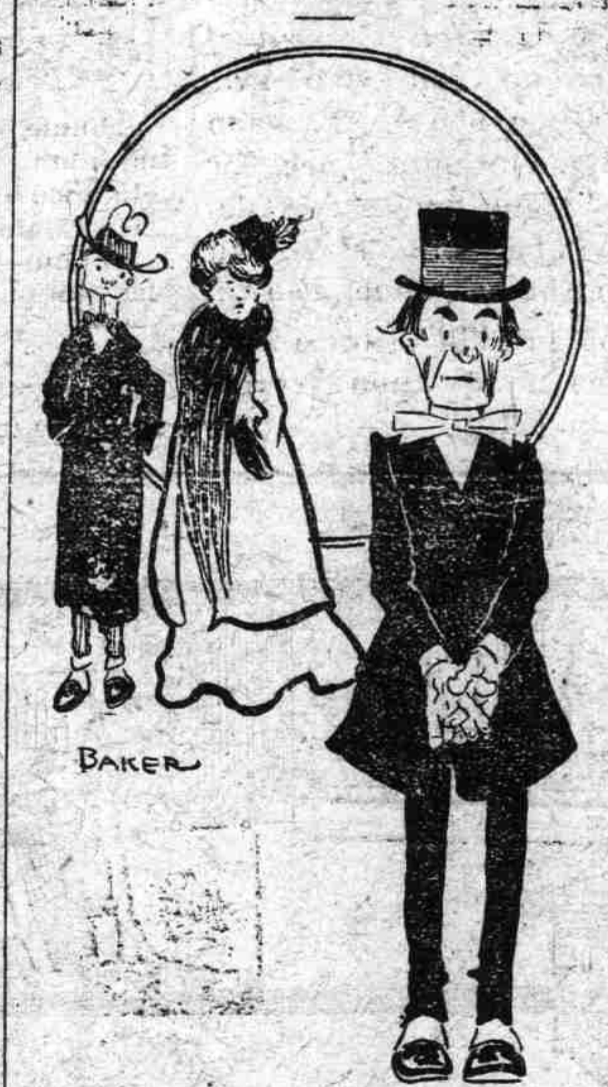
