



> ed.' The extension worker said that fertilizing materials are likely to be scarce in 1942 and 1943, and the use of the higher analysis mixture in smaller quantities will be a step in the direction of meeting the emergencies of war.

He said, however, that farmers who are unable to obtain the 6-9-3 mixture may buy the 4-9-3 fertilizer. The 4-9-3 material should be applied at the rate of two pounds per square yard.

"Growers should be careful not to use too much of the 6-9-3 fer-Rev. W. C. Cook, minister. than one pound per square yard is tilizer," Weeks warned. "If more than one pound per square yard is applied there is a possibility that the germination of the seed will be very low."


