

PALE OF U. S. IN UNDER PROHIBITION.

More Than 46,000,000 Persons Live in Territory Barring Liquor—New Law Unusually Strict.

Charleston, W. Va., June 28.—State-wide prohibition of the liquor business in West Virginia becomes effective next Tuesday midnight. It brings the total number of states in the prohibition column up to nine.

With West Virginia added, the list will be: Georgia, Kansas, Maine, Mississippi, North Dakota, North Carolina, Oklahoma, Tennessee, West Virginia. These nine states of total prohibition territory, plus the local no-license area, make up 2,132,720 square miles, in which 46,000,000 persons, or nearly 50 per cent of the country's population live, according to the latest figures of the prohibition leaders.

The 92,000 majority with which the people of West Virginia adopted the dry proposition was relatively the largest ever given by any state. It was approximately two to one for state-wide suppression of the liquor business. It was a surprise even to the prohibition forces, who were indebted largely to the determined stand which many of the large employers took in favor of their cause. The state has a population of 1,221,119, by the census of 1910.

The mandate of the legislature, embodied in the Yost bill for the enforcement of the new law, beginning July 1, departs in many respects from the methods hitherto tried along this line. The chief features center about the creation of a commissioner of prohibition, whose particular business it will be to see that by next Tuesday midnight some 1,200 liquor-selling places in the state have disposed of their stocks and that thereafter all persons shall be punished by law if they keep liquor for sale.

State Tax Commissioner Fred O. Blue, of this city, who becomes the new commissioner has been spending several months in preparation for strict enforcement of the new law.

To save the state the time and expense of taking violations before the state courts, he has urged municipal ordinances governing the violations, thus permitting the cases to be brought before the local courts.

BIG STORES UNDER THE BAN.

In an effort to instruct the people as to the provisions of the new law, Commissioner Blue has also been lecturing throughout the State.

"In other States," says Mr. Blue, "where prohibition has been adopted, one of the forces that has had to be contended with has been the drug store. The Yost law will regulate this feature. Druggists may sell alcohol only to persons not addicted to its use upon prescription of a reputable physician, who has examined the person and in detail set forth in the prescription the purposes for the use of alcohol. The governing bodies of druggists have approved of this plan.

"For scientific or mechanical purposes alcohol will be sold only after approval as to its intended uses, and uniform records of all such sales will be kept to be inspected periodically by those in charge of the enforcement of the law. No druggist, however, can sell in any form whiskey, brandy, ale or any beverage of an intoxicating nature.

"The Yost law also undertakes to do away with the drinking clubs, which have been the source of so much trouble in other states. It provides that any person directly or indirectly associated in keeping such a club, home or other place where liquor is kept for gift, barter or sale, shall be punishable upon conviction by a fine of from \$100 to \$500 and by imprisonment from one to six months.

"The enactment of the Webb-Kenyon law by congress will be of considerable assistance in enforcing the prohibition law in this state.

"One of the benefits of the federal act is that records of interstate shipments of liquors may be required, and, therefore, every railroad, express company and any kind of transportation company, including vessels carrying freight or express, either from another state into ours, or from one part of our state to another part, must obey the laws of this state respect-

ing liquors.

ALL MUST KEEP RECORDS.

"Every one of the transportation companies will be required to keep special records at the point of delivery showing the receipt of liquors, the kind and quantity, to whom consigned, when delivered, and the consignee must sign in person for the shipment. The Webb-Kenyon act vests the right to enforce these provisions of the law and regulation thereunder against interstate carriers. None of these carriers will be permitted to receive consignments of liquor at any point where there is not a regularly employed agent to keep such records, and have them open for inspection at all times.

"The man who is engaged in the steamboat business upon our waters, interstate or intrastate, may keep such records, and will not be permitted to deliver any liquors or make sale of any liquors upon board this vessel while in our waters.

"This brings us to the question of how one may get liquors for another. In the first place, if one acts as the agent of the seller, he is guilty of selling. If one acts as agent of the purchaser, he is guilty of selling. In other words, if one has occasion to go to some point out of the state, and a friend hands him a dollar and requests that he purchase for him a quart of whiskey, and he does it and delivers it to him, he is guilty of making the sale, and by the act is guilty of making it not where he purchases it, but where he delivers it in the state.

"Representatives of those who sell liquor cannot come into the State to solicit verbally, by letter, circular or otherwise. THE MILEAGE GRAFT.

Doughton Made Speech Recently in Which He Criticized Some of His Colleagues.

Washington, June 30.—Representative Doughton, of the eighth North Carolina district, dealt a few blows from the shoulder to these congressmen who desire to continue the present "mileage graft," when he made a speech in the house the other day denouncing the present law as one that has outlived its usefulness. Mr. Doughton said the law allowing 50 cents a mile each way to representatives and Senators, was based on the old stage coach mode of traveling. "There is no justification for it under the present modern methods," he said. Continuing Mr. Doughton said: "Mr. Speaker, I shall cheerfully support the amendment offered by the gentleman from Indiana (Mr. Cox) to reduce the amount allowed for mileage from 20 cents to 10 cents a mile. This question arises at each session of Congress, only to arise again at the next session. There must be some fundamental reason for its coming up at each session. In my judgment the agitation will continue until it is settled right, as all matters should be.

"The reason I support the amendment of the gentleman from Indiana is because experience has taught me again and again that it is impossible to get it reduced below that amount.

"The gentleman from Oklahoma (Mr. Murray) and the gentleman from Washington (Mr. Humphrey) go out of their way to read a moral lecture to the membership of this house and say that a man who does not bring his family here is unworthy to be a member of this body. Then intimate that that is the only way he can be kept in the path of moral rectitude. That is none of their concern. I say, without fear of successful contradiction, that a man who must be kept in the shadow of his family to keep his life circumspect and who would otherwise wander from the path of rectitude, is unworthy to be a member of this body. If that is all that restrains them from walking in the path of vice and evil, he will go there regardless of his surroundings.

"The gentleman from Washington takes advantage of this, as of every other occasion, to criticize the President of the United States, and speaks of us being kept here by White House domination, but the shafts of the gentleman from Washington fall harmlessly at the feet of the President. The President of the United States has not used any arbitrary means on this congress. True, he has constantly reminded Congress of its duty and pledges made to the people, and has, with courage and patriotism, pointed out the lines he would have us follow, but has wielded no big stick. In spite of all the criticism, deeds done, results accomplished and things performed, fully justify his action.

"Now, Mr. Speaker, I had rather pay my own way to Washington and receive not one cent of mileage than to be constantly accused of taking money out of the public treasury, to which I am not entitled. I do not say that it is graft; in fact, it is not, as long as sanctioned by law, but it is wrong and should, therefore be reduced.
