NOEL GIVEN FIFTEEN YEARS.

Guilty of Abducting Two Young Girls of Lexington and Carrying Them to a Disreputable Piace in Charlotte.

Lexington, N. C., Aug. 19 .- Chas. Noel was found guilty to-day of ab-

ducting Clara Belle Gibbs, daughter of E. H. Gibbs, of this city, and County, committed suicide Monday Judge Daniels sentenced him to fifteen years in the State Prison at hard labor. In passing sentence Judge Daniels expressed surprise that North Carolina harbored a citizen of Noel's vileness and he characterized him as a monster. There was evidence of

> the most convincing kind that Noel and his wife enticed Clara Belle Gibbs and Verta Kindley, aged 13 and 14, respectively, to leave their homes here for the purpose of placing them

in a house of ill-fame in Charlotte. It was a clear-cut case of white slavery and the two children were saved from a life of shame by mere chance. Warrants were issued for Noel and


his wife and Noel was arrested in Danville, Va., and brought back here.
