

SEARCH IS BEING MADE FOR WILL

C. C. West, Recluse Who Died Monday, Left Estate of About \$500,000.

disposal of an estate of half a million dollars or more, consisting partly of up town real estate, will be an after-math of the death Sunday of C. C. West, for years a wealthy resident and a picturesque character of Charlotte.

Whether he left a will could not be ascertained Monday. He did not retain a lawyer to handle his affairs, being a business man himself, seeking the services of attorneys only in carrying out legal points in transactions.

A real estate man, who has been close to Mr. West for years and who negotiated several large real estate deals for him in recent years, is of the opinion that Mr. West made a will some years ago, but he would not say beyond question that this was a fact.

Mr. West was unmarried and leaves a sister and other relatives. One of his properties is the building occupied by the Southern Hardware Company and the lot adjoining it on the East, now occupied by a fruit stand owned and operated by Tony Kiriakos, and the Atlanta Lunch, owned and operated by Charlie Anagnos.

Mr. West sold to J. B. Efrid and associates about a year ago the old Charlotte hotel site adjoining the city hall—on which the Efrids propose to erect a modern business building. The price for this property is understood to have been around \$210,000.

For the last 34 years, Mr. West had lived on South Mint street. He has had a housekeeper, but no close friends or members of his family shared the residence with him.

Something of the enhanced value of Charlotte realty in recent years was told Monday in connection with Mr. West's death. In 1905, he and the late Sheriff Z. T. Smith, joint owners of the old Charlotte hotel building and site, were offered \$25,000 for it. Mr. West objected. Later Sheriff Smith sold his interest in the property for \$15,000. About one year ago the Efrids are said to have paid \$210,000 for the same property.

MUCH CHAMPAGNE IS STILL COMING OVER

Washington, June 27.—"Dry" laws have not stopped the drinkers of sparkling French champagne.

Beat loads of that rare old luxury now being used by Americans. This fact is shown by French government figures disclosing large increases in shipments of champagne to the United States.

French champagne exported to American buyers last year, the first twelve months of national prohibitions, amounted to \$554,000.

In the preceding year, before the United States went into effect, France exported only \$1,158 worth of champagne to the United States.

American Consul General Thakara, at Paris, called attention to the heavier outflow of French wine to America in his latest official report to the Commerce Department. He said the movement of champagne this year is equally large.

Government experts said the figures disclosed that Americans, therefore, consumed nearly 400,000 quarts of French champagne after the dry law went on a little more than a year ago. French champagne and other rare wines from abroad are now coming in to American ports under special permits issued to importers authorized by the government to handle such liquors for medicinal or other uses enumerated under the dry statute.

SILENT BUT STRIKING. Denver, Colo., June 27.—Ella Cretzer, a Denver mute, worried because he is overcast, so he "invented" a contrivance that works as an alarm clock, assuring his rising at the desired hour.

Cretzer made a block of wood in the shape of a letter "T," the top of which is wrapped in heavy folds of cloth. The arm of the "T" is set under a wire that is connected with an alarm clock and the winding screw strikes the wire, releasing the block of wood, which tumbles down and strikes Cretzer on the head. "The best alarm clock I ever had," Cretzer says.

ENGLAND AIDED BEATEN GREEKS

Help Given Secretly in Violation of Agreement With Allies.

Paris, June 27.—England not only gave the Greeks moral encouragement in their recent ill-fated campaign against the Turks in Asia Minor, but lent financial assistance and the advice of military experts, according to information from reliable sources here.

This help was given secretly because it violated the Anglo-French-Italian agreement reached at the London conference. Through the French government, which has always worked for an understanding with Mustapha Kemal's Turkish nationalists, strongly opposed the Greek adventure, a number of French banks are said to have helped provide funds.

It is estimated that General Papoulas' campaign cost Greece at least \$30,000,000. It is known that the Bank of Greece was not prepared to furnish this sum and that King Constantine sent out distress signals for money before he ordered the offensive.

Exactly to what extent the English government participated directly in financing the campaign is not known here. Nevertheless, it is no secret in banking circles that several big London banks helped raise funds.

In Paris a group of banks which has large interests in Greece and the Near East lent enough additional support to enable Constantine to get along without worry, despite the fact that he is still waiting for recognition by the Allied governments.

At Constantinople the Greeks received not only military advice but an organization is said to have been created by the British embassy to help Constantine erect a civil administration if the Greek offensive had been a success.

Mustapha Kemal's representatives here report that among the dead found by the Turks as the Greeks retreated were numerous British officers and that several Britishers were taken prisoners. Athens dispatches admit that the British-Britone Shoe Company, which led a "counter-attack," but explain that he "happened" to be with the Greek troops and assumed command when their leader was killed.

FLIVER SERVES AS POWER GENERATOR

Rock River, Wyo., June 27.—The "flivver" is vindicated once more!

The Rock River Review, published by Royal A. Young and edited by his wife, Rose White Young, has a cylinder press usually driven by an electric motor that derives its power from the local light plant. When the plant was closed down recently because the owners declared, they were furnishing lighting and electrical power at a loss, Mr. Young found a perfectly good Cranston press on his hands; his "forms" for the daily paper were "locked up" and on the bed of the press and his mailing clerk was ready to get the paper into the mails. But there was no "juice." The motor would not go without power, and the press could not run papers without the motor being started.

While Young pondered the situation he thought of his flivver. Backing his faithful Ford up to the building, he hoisted one wheel off the ground, removed a tire, slipped the transmission belt of the press to the tireless wheel, and started the engine.

The edition was run off at the rate of 1,700 papers an hour, the tire was replaced on the wheel; the Ford was let down onto terra firma again and the folded papers thrown into its tonneau, whence they were delivered to the subscribers.
