BELDOC PLANTER IS YET SERIOUSLY ILL

Augusta, Ga., Nov. 29.—J. W. Lee, the Beldoc, S. C., planter, who was brought to a local hospital three weeks ago today, suffering from a strange malady which quickly resulted in the death of his wife and three children and which was believed by residents of the Beldoc section to have been caused by poison put into a well on the Lee farm, is still seriously ill, very little change having been shown in his condition.

Sheriff Bennett, of Allendale county, stated this morning that he was still awaiting reports from the laboratories at Charleston and Columbia, where organs removed from the body of Mrs. Lee were sent, before taking any action.

Dr. J. H. Butler, who is attending Mr. Lee at the hospital here, states that the sick man shows little signs of improvement. Dr. Butler said he had made a blood test but refused to reveal what it showed.

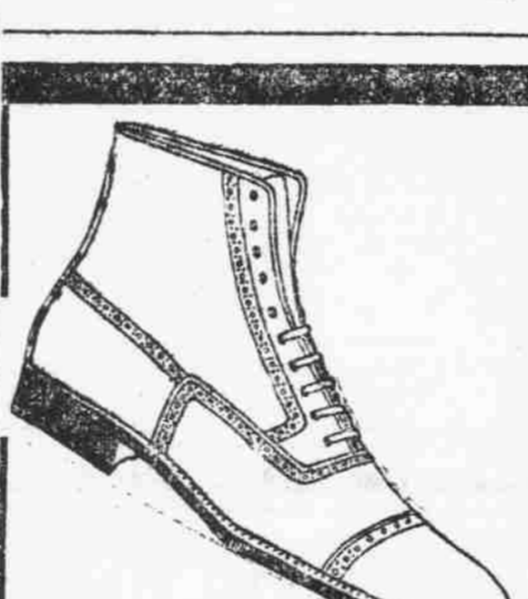
COMPLETION OF JURY TODAY HOPED FOR

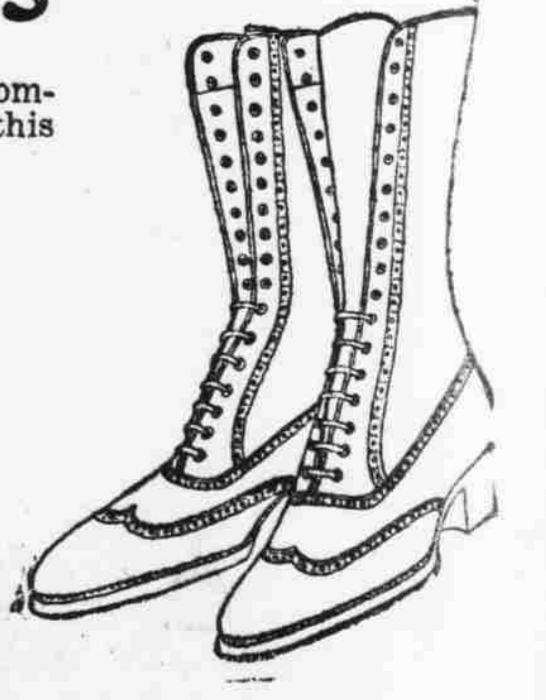

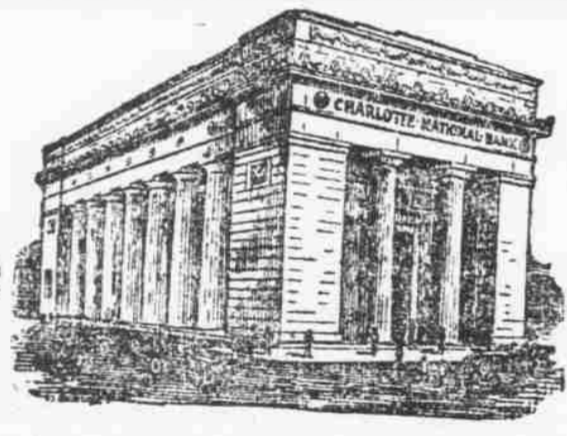
