Sec. 2 The Student Council shall hold a regular meeting at least once a month and said meetings shall be open to all members of the Faculty and Student Government. A quorum for business meetings shall be one-third of the total Student Council membership. In all meetings of the Student Council Robert's Rules of Order shall be the parliamentary procedure.

Sec. 3 All Student Council members shall be required to report their expected absences to the President before the scheduled meeting and make a definite report before the Student Council at the following meeting. Two consecutive unexcused absences or three unexcused nonconsecutive absences shall automatically bar a member from the Student Council. The members of the Student Council shall decide whether an absence of any member is excused or unexcused.

Sec. 4 The powers and duty of the Student Council shall incorporate: upholding of the Student Constitution; planning and supervision of all social activities; supervision of expenditures made from student funds; supervision of student behavior at all Student Government functions; trial and recommendation of punishment of any student guilty of misbehavior at student functions and/or violation of the Honor System.

ARTICLE VI

ARTICLE VIII Honor System Sec. 1 The Honor System shall Association

be in effect in the Charlotte College.

Sec. 2 Every student shall be tee. It shall be the duty of the honor bound to refrain from lying, cheating, or stealing.

Sec. 3 Every student shall be honor bound to report to the Student Council any and all violations of the Honor System which shall come under his observation. Failing to make such a report shall in itself constitute violation of the Honor System.

Sec. 4 The Student Council shall assume responsibility for trial and recommendation of punishment for any violation of the Honor System reported by any member of the Faculty or any date has the privilege of sending member of the Student Government.

Sec. 5 It is within the power of the Student Council to recommend probation, suspension, or expulsion of all proved violators of the Honor System.

ARTICLE IX Amendments

Sec. 1 Three-fourths of the votes cast are necessary to amend this Constitution.

Sec. 2 A petition signed by 15% of the total membership of the Student Government and presented to the Student Council shall constitute the necessity of setting up the machinery for an election to decide the constitutional amendment.

Sec. 3 The proposed constitutional amendment must be in the hands of the Student Govern- New Courses ment at least two weeks prior to the election which shall be held not later than three weeks after the petition for this amendment has been submitted to the Student Council.

ARTICLE X Ratification

This Constitution will take effect immediately upon ratification by a three-fourth majority of the votes cast in an election held specifically for this purpose by the students of Charlotte Col-

As this issue of the Charlotte Collegian goes to press, word has been received that Charlotte College has been accredited by the American Association of Junior Colleges.

Membership in the Association means that the work of students of Charlotte College is transferable to all schools in North Carolina and in the United States. According to Miss Bonnie E. Cone, Director of Charlotte College, the American Association of Junior Colleges is the highest ranking organization of which Charlotte College, as a junior college, could be a member. The Association membership is made up of approximately 500 junior colleges

The college has held a provisional membership in the Association since July, 1949, but it was not until July of this year that the college was granted active membership by the Board Induction of Directors of the Association Before active membership could be granted, it was necessary that the college be accredited by the North Carolina Department of Public Instruction. This approval was released in June of this year and was retroactive to September, 1949, when the school first began operation as a part of the Charlotte school system.

A beginner's course in Gregg shorthand will be given, as will a refresher course designed to help the student increase his speed in taking dictation. Typewriter courses will be open to beginners and advanced students.

Postponement For Students

The latest information received from the local Selective Service office is that full time students ordered to report for induction may apply for postponement of their induction until the end of the school year during which the induction order is received.

The procedure to be followed by students seeking such postponement is: The first notice received by the selectee will be an order to report for physical examination. This order must be complied with regardless of any postponement which may be granted later. If found to be physically qualified for service, the selectee will receive in due course an order to report for induction. 
