We have endeavored to give our readers the benefit of the best synopsis we could of the speech Thursday night by Senator Pritchard. It was an able production delivered in a way unoffensive to those of opposite views and the whole manner of the speaker was calculated to win to his theories. He is skillful in the manipulation of figures and in turning, what seems to be facts, against his opponents when it is clear that he could take the same facts and turn them with equal force in the very opposite direction. He ventured upon a few follies that were amazing at this late day of tariff education. We have neither time nor space today to note some clear and palpable misleadings of the speech to which we shall refer later, while of course there is much in his manipulations that are fitted in his story of the preacher who said to his congregation: "Some things

about the subject you will understand and I won't; some things I will understand and you won't, and some things neither of us will understand."

### MR. BRYAN'S ACCEPTANCE.

His Letter Made Public This Morning—Wants to Enter Office Free From Any Personal Desire Except to Prove Worthy of the Confidence of the Country—His Able Analysis and Defense of the Democratic Form of Government.

LINCOLN, Neb., Sept. 9.—Mr. Bryan today made public his letter accepting the Democratic nomination. In opening he says: I accept the nomination tendered by you on behalf of the Democratic party. In so doing, I appreciate the high honor and grave responsibilities and am deeply impressed with the magnitude of the power vested and the enormous influence which can be wielded for the benefit or injury of the people. I wish to enter the office if elected free from any personal desire except to prove worthy of the confidence of the country. He says that human judgment is fallible enough when unbiased by selfish consideration. He will not use the patronage of office to advance a personal ambition. He announces emphatically that under no circumstances, if elected, will he be a candidate for re-election. He unequivocally endorses every plank in the platform, and says the Democratic form of government is conducive to the highest degree of civilization, because it opens to each individual the greatest opportunities for developments and stimulates to the highest their endeavors by insuring to each the full enjoyment of all rewards of toil; except such contribution as is necessary to support the government which protects him; it ignores all differences of wealth, knows no creed and welcomes all to a common brotherhood. It guarantees equal treatment to all. The Democratic party is pledged to defend the laws of the Constitution. It will be noticed while the United States guarantees to every State a Republican form of government and empowered to protect each State against invasion, it is not authorized to interfere in the domestic affairs of State, except upon application to the legislature of her State or upon application of the Executive, when the legislature is not in session, this theory being based upon the supposition that each State, because intimately acquainted with local conditions, is better qualified than the President to judge the necessity for federal assistance.

### Joe Myers' Sentence.

Joseph P Myers, the former cashier of the Seaboard Air Line in this city, who embezzled about \$3,500 of the company's money and fled with a woman to New York, where he was shortly afterwards captured and returned to Charlotte, was arraigned before Judge Meares in the Criminal court this afternoon. The court house was packed with people curious to see the outcome.

Myers was neatly dressed and looked well. He was represented by Col. H C Jones, who made an eloquent plea in his behalf proposing that his client would make full reparation to the company paying back all the money misappropriated.

Col. Jones spoke briefly, but effectively. After hearing him through Judge Meares fixed Myers penalty as follows: He is to make immediate restitution of the balance of the money to the Company, amounting to \$1,900; and he is to serve a sentence of six months in the county jail and to pay a fine of \$500.

Myers was at once taken back to jail. It is understood that his uncle sent him the funds to make good his default.—Charlotte News.
