PROPOSED AMEND-MENT.

Text of the Measure Agreed Upon by the Democratic Legislative Caucus Wednesday and to be Submitted to Vote of the People.

constitution of North Carolina be, and the same is hereby repealed, tion shall register. and in lieu thereof shall be substitued the following article of said constitution:

ARTICLE VI.

Suffrage and Eligibility to Office-Qualifications of an Elector.

Secton 1. Every male person born in the United States, and every male person who has been naturalized, 21 years of age and possessing the qualifications set out in this article shall be entitled to vote at any election by the people in the State, except herein otherwise provided.

Section 2. He shall reside in the State of North Carolina for two years, in the county six months, and in the precinct, ward or other election district in which he offers to vote four months next preceding the election; provided, that removal from one precinct, ward or other election district, to another in same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district, from which he has removed until four months after such removal. No person who has been convicted, or who has confessed his guilt in open court upon indictment, of any crime, the punishment, of which is, or may hereafter be imprisonment in the State prison, shall be permitted to vote unless the said person shall be first restored to citizenship in the manner prescribed by law.

Section 3. Every person offering to vote shall be at the time a legally registered voter as hereinafter prescribed by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this article.

Section 4.
